1. The amounts so appropriated above by the General Assembly were apportioned among Member States in accordance with the provisions laid out in section I.B below and as shown in section III.A through G.

B. Apportionment of the costs of peacekeeping operations

2. On 11 December 1973, the General Assembly adopted resolution 3101 (XXVIII) on the financing of the United Nations Emergency Force (UNEF II). Under the resolution, the membership of the United Nations was divided into four groups: (a) the States permanent members of the Security Council; (b) specifically named economically developed Member States that were not permanent members of the Security Council; (c) economically less developed Member States; and (d) economically less developed Member States that were specifically named. The resolution also specified the amounts of the total appropriation to be distributed among each of the four groups.

3. The four amounts specified in the resolution were established by a methodology intended to produce the following results: the Member States in group D would pay 10 per cent of the assessment rates established for the regular budget, those in group C would pay 20 per cent, those in group B would pay 100 per cent and those in group A would pay 100 per cent plus the amounts not otherwise apportioned.

4. Within each group, according to the terms of resolution 3101 (XXVIII), the amount appropriated was to be distributed among the respective group members on the basis of the relative weight of each group member's regular rate of assessment in relation to the total rate for the group.

5. The scheme for the apportionment of costs set out in resolution 3101 (XXVIII) has continued to be applied since that time for all peacekeeping operations financed through assessed contributions, including UNIKOM. The composition of the four groups of Member States has changed repeatedly since 1973, however, as a result of the admission of new Member States and the decisions contained in the various General Assembly resolutions, the latest of which was resolution 43/232 of 1 March 1989, as adjusted by resolutions 44/192 B of 21 December 1989, 45/269 of 27 August 1991, 46/198 A of 20 December 1991, 47/218 A of 23 December 1992, 49/249 A of 20 July 1995 and 49/249 B of 14 September 1995, 50/224 of 11 April 1996, 51/218 A to C of 18 December 1996, 52/230 of 31 March 1998, 55/235 and 55/236 of 23 December 2000 and 57/290 of 20 December 2002, and its decisions 48/472 A of 23 December 1993, 50/451 B and 50/471 A of 23 December 1995 and decisions 54/456, 54/457 and 54/458 of 23 December 1999. The percentage shares shown in section III.B and C below demonstrate the results of the application of the scheme, using the scale of assessments for 2001, as adopted by the General Assembly in its resolution 55/5 B of 23 December 2000.

6. Beginning in July 2001, the General Assembly, by its resolution 55/235, decided that "the assessment rates for the financing of peacekeeping operations should be based on the scale of assessments for the regular budget of the United Nations, with an appropriate and transparent system of adjustments based on levels of Member States ...". Under this system Member States were assigned to 1 of 10 "levels" to facilitate automatic, predictable movement between categories on the basis of the per capita gross national product (GNP) of Member States. Discount rates were applied to eight of the different levels based on the parameters set forth in the resolution. Countries in level B are assessed at the same rate as for the regular budget. Member States other than those assigned to levels A, C and J were assigned to levels based on their per capita GNP, subject to transition periods and unless they

indicated a decision to move to a higher level. The Member States which voluntarily moved to a higher level are indicated in resolutions 55/235 and 55/236.

7. The five permanent members of the Security Council form a separate level, level A, and all discounts resulting from adjustment to the regular budget assessment rates of Member States in levels C through J are borne on a pro rata basis by the Member States in level A, which are assessed at a higher rate than for the regular budget. Member States designated as least developed countries are assigned to level J and receive the highest discount percentage, i.e., 90 per cent. They therefore pay 10 per cent of their assessment rates established for the regular budget. Countries in level C are specified in resolution 55/235. The percentage shares shown in section III.A and D through G below demonstrate the results of the application of the new system, using the scale of assessments for 2002 and 2003, as adopted by the General Assembly in its resolution 55/5 B of 23 December 2000 and adjusted by its resolution 57/4 B of 20 December 2002.

II. Basis for credits in respect of the Tax Equalization Fund

8. Under regulation 3.2 (e) of the Financial Regulations and Rules of the United Nations, adjustments shall be made to the assessment of Member States in respect of their credits in the Tax Equalization Fund estimated to be not required to meet charges for tax refunds for the financial periods below:
