

1. At its 1st plenary meeting, on 13 September 2005, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixtieth session the item entitled:

"Operational activities for development:

- "(a) Operational activities for development of the United Nations system;
- "(b) South-South cooperation: economic and technical cooperation among developing countries"

and to allocate it to the Second Committee.

2. The Second Committee considered the item at its 24th, 25th, 30th, 35th and 36th meetings, on 9 and 15 November and 9 and 13 December 2005. At the 24th meeting, on 9 November 2005, introductory statements were made by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs of the Department of Economic and Social Affairs; the representative of the Joint Inspection Unit; the Director of the secretariat of the United Nations System Chief Executives Board for Coordination; the Deputy Director for Programmes of the United Nations Development Fund for Women; and the Chief of the Division for Policy Partnerships and Resources of the Special Unit for South-South Cooperation of the United Nations Development Programme (see A/C.2/60/SR.24).

At the same meeting, pursuant to section C, paragraph 3 (d), of the annex to General Assembly resolution 58/316 of 1 July 2004, the Committee held a dialogue with the substantive representatives during which comments were made and questions were posed by the representatives of the United Kingdom of Great Britain and Northern Ireland (on behalf of the European Union), Egypt, Morocco and France (see A/C.2/60/SR.24).
