## Annotations

#### 1. Election of officers

In accordance with rule 18 of the rules of procedure of the Economic and Social Council, each year, at the commencement of its first meeting, the Committee elects its Chairperson and four Vice-Chairpersons. In accordance with rule 19, Bureau members are eligible for re-election. One of the Vice-Chairpersons is later designated also to serve as Rapporteur.

### 2. Adoption of the agenda and other organizational matters

In accordance with rule 13 of the rules of procedure of the Council, the Committee shall, at the beginning of each session, after the election of its officers, adopt the agenda for that session on the basis of the provisional agenda. The provisional agenda for the current session was approved by the Council in its decision 2005/241.

# **3.** Applications for consultative status and requests for reclassification received from non-governmental organizations

# (a) Applications for consultative status and requests for reclassification deferred from the previous session of the Committee

The Committee will consider applications and requests for reclassification deferred from the sessions of previous years.

The Committee will consider quadrennial reports submitted by non-governmental organizations deferred from previous sessions of the Committee held in 1999, 2000, 2001, 2002, 2003, 2004 and 2005. The Committee will also consider quadrennial reports submitted by organizations on their activities during the period 2001-2004.

# 5. Strengthening of the Non-Governmental Organizations Section of the Secretariat

In view of the expansion of the functions and responsibilities of the Non-Governmental Organizations Section of the Secretariat to meet the demand of a growing number of applications for consultative status, as well as the demands of a larger and more active non-governmental organizations community, the Committee decided, at its 2005 regular and resumed sessions, that the strengthening of the Section should continue to be a priority during its 2006 session.

At its 2000 session, the Committee established an informal working group, open to all interested members of the Committee, to review its methods of work, including accreditation issues, procedures, coordination with the secretariat of the Commission on Human Rights, enhancement of the non-governmental organizations information process and security issues. At its 2005 session, the Committee reviewed a number of issues that had been placed on the agenda of the informal working group and decided that the group continue its work. The Secretariat will report to the Committee on the subject.

Those applications would be considered as

expeditiously as possible under an agenda item of the Committee. The Committee would also consider applications deferred from previous sessions.
