ELECTION, IN ACCORDANCE WITH PART IV (ARTICLES 28 to 34) OF THE INTERNATIONAL COVENANT ON CIVIL AND POLITICAL RIGHTS, TO FILL A VACANCY IN THE HUMAN RIGHTS COMMITTEE

Note by the Secretary-General

1. In conformity with article 30, paragraph 4, of the International Covenant on Civil and Political Rights, the Sixth Meeting of the States parties to the Covenant will be convened by the Secretary-General at United Nations Headquarters on Friday, 18 November 1983, for the purpose of filling a vacancy in the Human Rights Committee created as a result of the resignation of Mr. Walter TARNOPOLSKY (Canada) who had been re-elected at the Third Meeting of the States parties in September 1980 for a term expiring on 31 December 1984.

2. In accordance with article 33, paragraph 2, and article 34, paragraphs 1 and 3 of the Covenant, the Secretary-General in a note verbale dated 5 August 1983 invited the States parties to submit, in conformity with article 29 of the Covenant, their nominations within two months, i.e. by 5 October 1983, for the election of one member of the Committee.

3. In compliance with the provisions of article 34, paragraph 2, of the Covenant, the Secretary-General has the honour to indicate below, in alphabetical order, the names of the persons nominated by 5 October 1983 for election to fill the vacancy, indicating the States parties which have nominated them:
