Letter dated 28 November 1983 from the Permanent Representative of Iraq to the United Nations addressed to the Secretary-General

On instructions from my Government, I have the honour to transmit herewith information consisting of excerpts from official Iraqi military communiqués issued during the period from 7 to 25 November 1983 concerning the shelling of civilian targets within Iraqi territory by the Iranian aggressor forces, which resulted in losses among the civilian population and damage to civilian installations.

I request you to have this letter and its annex circulated as an official document of the General Assembly, under agenda item 138, and of the Security Council.

The shelling of the city of Mandali and its environs, the town of Sayyid Sadiq and the district of Shandarayy. The shelling resulted in damage to a number of civilian installations there (communiqué No. 1272 of 7 November 1983).

The shelling of the city of Mandali and its environs. The shelling resulted in damange to a number of civilian installations there (communiqué No. 1273 of 9 November 1983).

The shelling of the towns of Sayyid Sadiq and Khurmal and their environs. The shelling resulted in damage to a number of civilian installations there (communiqué No. 1275 of 10 November 1983).

The shelling of the subdistricts of Qarat and Khurmal and their environs. The shelling resulted in the destruction of three dwelling-houses in Qarat and damage to a number of civilian installations in Khurmal (communiqué No. 1276 of 11 November 1983).

The shelling of the towns of Sayyid Sadiq and Khurmal and their environs. The shelling resulted in damage to some civilian installations there (communiqué No. 1279 of 14 November 1983).

The shelling of the city of Mandali and its environs. The shelling resulted in damage to a number of civilian installations there (communiqué No. 1280 of 15 November 1983).

The shelling of the cities of Mandali and Khanaqin and their environs. The shelling resulted in the destruction of three dwelling-houses in the city of Mandali (communiqué No. 1981 of 16 November 1983).

The shelling of the city of Khanaqin and the town of Shandarayy and their environs. The shelling resulted in damage to a number of civilian installations there (communiqué No. 1283 of 18 November 1983).

The shelling of the city of Mandali and its environs, the town of Sayyid Sadiq and the district of Shandarayy. The shelling resulted in damage to a number of civilian installations there (communiqué No. 1284 of 19 November 1983).

The shelling of the city of Basra and its environs. The shelling resulted in damage to a number of civilian installations there and the wounding of one woman and one child (communiqué No. 1287 of 21 November 1983).

The shelling of the city of Mandali and the towns of Shihabiyah and Sayyid Sadiq and their environs. The shelling resulted in the wounding of one woman in Mandali (communiqué No. 1288 of 22 November 1983).

The shelling of the city of Mandali and its environs. The shelling resulted in damage to a number of civilian installations there (communiqué No. 1289 of 23 November 1983).

The shelling of the city of Mandali, the town of Sayyid Sadiq and the subdistrict of Khurmal and their environs. The shelling resulted in the martyrdom of four civilians (including one child), the wounding of two others in Sayyid Sadiq and the infliction of various wounds on two civilians in Khurmal (communiqué No. 1291 of 25 November 1983).
