# Paragraph 1., amend to read:

### "1. SCOPE

1.1. This Regulation applies to vehicles of categories M and N 1/ and their engines, as shown by Table A, with regard to the tests foreseen for these engines in Table B.

### 1.2. Equivalent approvals

The following do not need to be approved according to this Regulation, if they are part of a vehicle approved according to Regulation No. 83:

- (a) compression-ignition engines to be mounted in vehicles of categories  $N_1$ ,  $N_2$  and  $M_2$  1/fuelled with diesel;
- (b) positive-ignition engines fuelled with natural gas (NG) or liquefied petroleum gas (LPG) to be mounted in vehicles of category  $N_1$ .  $\underline{1}''$

Regulation No. 83 applies only for vehicles with a reference mass =  $2,840 \, \text{kg}$  as an extension of an approval given for an engine used in vehicles of categories  $M_1$  or  $N_1$ . 1/2

Paragraph 4.6.1., the reference to footnote  $\frac{4}{4}$  and footnote  $\frac{4}{4}$ , renumber as footnote  $\frac{2}{4}$  and amend to read:

"2/ 1 for Germany, ...., 36 for Lithuania, 37 for Turkey, 38 (vacant), 39 for Azerbaijan, ...., 47 for South Africa, 48 for New Zealand, 49 for Cyprus, 50 for Malta, 51 for the Republic of Korea, [52 for Malaysia and 53 for Thailand]. Subsequent numbers shall be assigned .... "
