Note by the Secretary-General

- 1. In pursuance of General As embly resolution 268 D (III) of 28 April 1949 on the promotion of international co-operation in the political field, a panel for inquiry and conciliation was created, and information concerning the composition of the panel has from time to time been communicated to the Security Council, the last consolidated list being contained in document S/1933.
- 2. Inasmuch as resolution 268 D (III) provides that persons designated by Governments shall serve on the panel for a term of five years, many of the original appointments have expired, and the Secretary-General has received renewals of some designations as well as new designations. For the convenience of the members of the Security Council, therefore, the Secretary-General has the honour to communicate herewith a revised list of names of persons whose designations by member States for inclusion in the panel are currently in effect.
