# Comprehensive review of the whole question of peacekeeping operations in all their aspects

#### **Report of the Special Political and Decolonization Committee** (Fourth Committee)

### I. Introduction

1. Information on the consideration of agenda item 32 by the Special Political and Decolonization Committee (Fourth Committee) appears in the report of the Committee contained in document A/60/478.

2. The Fourth Committee considered this item at its 13th to 16th meetings, on 20, 21, 24 and 25 October 2005 (see A/C.4/60/SR.13-16).

3. The Fourth Committee resumed its consideration of the item at its 26th meeting, on 12 May 2006 (see A/C.4/60/SR.26). The representative of Egypt, in his capacity as the Rapporteur of the Special Committee on Peacekeeping Operations, introduced the report of the Special Committee (A/60/19).

## II. Consideration of draft resolution A/C.4/60/L. 19

4. At the 26th meeting, on 12 May 2006, the representative of Egypt, on behalf of Argentina, Canada, Egypt, Japan, Nigeria and Poland, introduced a draft resolution entitled "Comprehensive review of the whole question of peacekeeping operations in all their aspects" (A/C.4/60/L.19).

5. At the same meeting, the Committee was informed that the draft resolution would not give rise to financial implications at that stage.

6. Also at the same meeting, the Committee adopted draft resolution A/C.4/60/L.19 without a vote (see para. 8).

06-35721 (E) 250506 \* 0635721 \* 7. After the adoption of the draft resolution, statements were made by the representative of Austria, on behalf of the European Union, and by the representative of Morocco, on behalf of the Non-Aligned Movement (see A/C.4/60/SR.13-16).

#### **III.** Recommendation of the Special Political and Decolonization Committee (Fourth Committee)

8. The Special Political and Decolonization Committee (Fourth Committee) recommends to the General Assembly the adoption of the following draft resolution:

# Comprehensive review of the whole question of peacekeeping operations in all their aspects

The General Assembly,

*Recalling* its resolution 2006 (XIX) of 18 February 1965 and all other relevant resolutions,

*Recalling in particular* its resolutions 59/281 of 29 March 2005 and 59/300 of 22 June 2005,

Affirming that the efforts of the United Nations in the peaceful settlement of disputes, including through its peacekeeping operations, are indispensable,

*Convinced* of the need for the United Nations to continue to improve its capabilities in the field of peacekeeping and to enhance the effective and efficient deployment of its peacekeeping operations,

*Considering* the contribution that all States Members of the United Nations make to peacekeeping,

*Noting* the widespread interest in contributing to the work of the Special Committee on Peacekeeping Operations expressed by Member States, in particular troop-contributing countries,

*Bearing in mind* the continuous necessity of preserving the efficiency and strengthening the effectiveness of the work of the Special Committee,

1. *Welcomes* the report of the Special Committee on Peacekeeping Operations;<sup>1</sup>

2. *Endorses* the proposals, recommendations and conclusions of the Special Committee, contained in paragraphs 28 to 188 of its report;

3. Urges Member States, the Secretariat and relevant organs of the United Nations to take all necessary steps to implement the proposals, recommendations and conclusions of the Special Committee;

4. *Reiterates* that those Member States that become personnel contributors to the United Nations peacekeeping operations in years to come or participate in the future in the Special Committee for three consecutive years as observers shall, upon request in writing to the Chairman of the Special Committee, become members at the following session of the Special Committee;

5. *Decides* that the Special Committee, in accordance with its mandate, shall continue its efforts for a comprehensive review of the whole question of

peacekeeping operations in all their aspects and shall review the implementation of its previous proposals and consider any new proposals so as to enhance the capacity of the United Nations to fulfil its responsibilities in this field;

6. *Requests* the Special Committee to submit a report on its work to the General Assembly at its sixty-first session;

7. *Decides* to include in the provisional agenda of its sixty-first session the item entitled "Comprehensive review of the whole question of peacekeeping operations in all their aspects".
