PROPOSED PROGRAMME CHANGES FOR THE BIENNIUM 2006-2007

Note by the secretariat

SUMMARY

The present document contains proposed changes to the programme of work, 2006-2007. The changes are necessitated by new mandates adopted by the Commission at its sixty-first session, as well as the emerging global priorities identified by the Economic and Social Council and the General Assembly and other global conferences since the Commission adopted the draft programme of work, 2006-2007 at its sixty-first session.

The major changes result from Commission resolution 61/1 of 18 May 2005 on the mid-term review concerning the functioning of the conference structure of the Commission. In this regard, the thematic committees will be retained to keep the work of ESCAP focused on three key thematic areas, poverty reduction, managing globalization and addressing emerging social issues. The work of the subcommittees will be subsumed under the respective thematic committees from 2006 onwards.

The changes have no additional regular programme budget implications.

The Commission may note that as the United Nations Secretariat moves from output-oriented reporting to results-based management, minor programme changes will be reflected in the ESCAP programme performance report at the end of the biennium.

The Commission is invited to consider the proposed changes with a view to endorsing them for incorporation in the programme of work, 2006-2007.
