Served on various law courts, 1933-1943; Associate Judge, Court of Appeals, Stockholm, 1943; Director, Legal Department, Ministry of Foreign Affairs, 1949-1963, with the personal rank of Ambassador since 1957; legal adviser to the Swedish delegation to the United Nations General Assembly, 1948-1961; alternate Vice-President of the Swedish Labour Court, 1951-1963; member of the Administrative Tribunal of the United Nations since 1952; member of the European Commission of Human Rights since May 1954, President of the Commission since 1962; member of the

Board of the Institute for Studies in History of Law since 1947; Assistant Professor, Stockholm University of Economics, 1947-1959; member of the Permanent Court of Arbitration since 1955; President of the Arbitral Tribunal constituted to settle the dispute between the Governments of France and Spain regarding Lake Lanoux, 1958; President of the Royal Svea Court of Appeal in Stockholm since September 1963; Member of the Chapter of the Diocese of Stockholm since 1955; Chairman of the Swedish National Committee for Cultural Co-operation in Europe since 1964; Chairman of the Board of the Museum of Skansen since 1963; Vice-Chairman of the Swedish Touring Club since 1965; Head of the Swedish delegations to various diplomatic and other international conferences; various other functions and duties with respect to legal and cultural matters.
