CABLE DATED 20 AUGUST 1965 FROM THE ASSISTANT SECRETARY-GENERAL OF THE ORGANIZATION OF AMERICAN STATES ADDRESSED TO THE SECRETARY-GENERAL OF THE UNITED NATIONS

In the absence of the Secretary-General, I have the honour to transmit to you for the information of the Security Council, in accordance with Article 54 of the Charter of the United Nations, the text of cable No. 551 of today's date, sent by the Ad Hoc Committee to the Chairman of the Tenth Meeting of Consultation:

"Santo Domingo, 20 August 1965

"H.E. Dr. Guillermo Sevilla Secasa Chairman, Tenth Meeting of Consultation of Ministers of Foreign Affairs Washington, D.C.

"Sir,

"As you will recall, operative paragraph 5 of the resolution adopted on 6 May 1965 by the Tenth Meeting of Consultation of Ministers of Foreign Affairs, establishing the Inter-American Peace Force, lays down:

'(5) That the withdrawal of the inter-American force from the Dominican Republic shall be determined by this Meeting'.

"This provision was the only appropriate method which could be foreseen at the time of adoption of the resolution, in so far as the withdrawal of the Force was concerned.

"However, as is also known to the Tenth Meeting of Consultation of Ministers of Foreign Affairs, the proposal for the solution of the Dominican crisis submitted by the Ad Hoc Committee envisages the establishment of a provisional government in the Dominican Republic as soon as possible. This provisional government will be sovereign and internationally recognized, and will be responsible for the maintenance of law and order throughout the national territory.

"The Ad Hoc Committee therefore has the honour to recommend to the Tenth Meeting of Consultation of Ministers of Foreign Affairs that, as soon as the

provisional government has been installed in the Dominican Republic, a resolution should be adopted providing that the manner and date of the withdrawal of the Inter-American Peace Force shall be decided upon by the provisional government, jointly with the Tenth Meeting of Consultation of Ministers of Foreign Affairs, on the initiative of the President of the Provisional government, when he considers it desirable.
