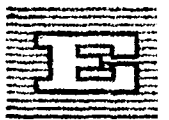

INTRODUCTION

By virtue of section A of General Assembly resolution 421 (V) and the resolution of the Economic and Social Council adopted on 23 February 1951 (E/1927) (see document E/CN.4/525), the Commission on Human Rights is called upon to continue to give priority in its work to the completion of the draft Covenant and measures for its implementation, in order that the General Assembly may have the revised draft of the Covenant before it at its sixth session.

In section B of the General Assembly resolution the Commission is requested to take into consideration in its work of revising the draft Covenant views expressed during the discussion of the draft Covenant at the fifth session of the General Assembly and at the eleventh session of the Economic and Social Council.

In the Council resolution E/1927 the Commission is also called upon to take into consideration in its work on the draft Covenant the records of the discussion at the twelfth session of the Council.

In his memorandum, document A/C.3/535, the Secretary-General submitted to the Third Committee of the General Assembly a subject analysis of the discussions on the draft Covenant during the eleventh session of the Council. In the present document he supplements this subject analysis by presenting a subject analysis of the discussions, draft resolutions and resolutions of the fifth session of the General Assembly.
