The PRESIDENT: The Assembly will now consider the Secretary-General's request for the inclusion of an additional item in the agenda of the forty-third session.

In this connection a note by and a report of the Secretary-General have been circulated in documents A/43/997 and Addendum 1. In his note the Secretary-General, pursuant to rule 15 of the rules of procedure, requests that an additional item of an important and urgent character be placed on the agenda entitled "Financing of the United Nations Transition Assistance Group". Owing to the nature of the item, he also requests that the item be allocated to the Fifth Committee for consideration.

Under the circumstances of the present case, may I take it that the General Assembly agrees that the provision of rule 40 of the rules of procedure, which would require a meeting of the General Committee on the question of the inclusion of an additional item on the agenda, could be waived?

It was so decided.

The PRESIDENT: May I also take it that the Assembly wishes to include an additional item to read "Financing of the United Nations Transition Assistance Group" and to allocate that item to the Fifth Committee for consideration?

It was so decided.

The PRESIDENT: The Assembly will meet again at a date and time to be announced in the Journal to consider the report of the Fifth Committee with a view to approving it as expeditiously as possible.
