

CEASE-FIRE VIOLATIONS COMMITTED BY INDIAN ARMED FORCES DURING THE PERIOD 24 APRIL TO 13 MAY 1972

NORTHERN AREAS

- 1. At 0900 hours on 24 April 1972, Indian troops encroached area grid reference KM 118830 and fired at Pakistan patrol with machine-gun when challenged.
- 2. On 5 May 1972, Indian troops fired approximately 30 rounds of mortar on Pakistan position.
- 3. On 7 May 1972, Indian troops fired with mortars from area grid reference NN1684.
- 4. On 10 May 1972, Indian troops fired approximately 30 rounds of mortar on Pakistan position in area grid references 158886, 191897, 143907 and 155894.
- 5. On 11 May 1972, Indian troops fired intermittently on Pakistan position in area grid reference 1289 in Minimarg sector.
- 6. On 11 May 1972, Indian troops fired 45 bombs from 4.2-inch mortars at position in area grid reference 1687 and also fired with mortars at positions in area grid references 1290 and 1490 in Minimarg sector.
- 7. On 12 May 1972, Indian soldiers were observed constructing new bunkers in area grid reference 0893 in Olding sector.

KASHMIR SECTOR

- 1. On 24 April 1972, Indians were observed constructing bunkers in area grid reference 985394 in Tithwal sector.
- 2. On 24 April 1972, Indian troops fired intermittently 19 bombs of mortar from area grid reference 9139 bowards Pakistan positions in Lipa sector.
- 3. On 25 April 1972, Indian troops fired intermittently 45 bombs of mortar from area grid reference 3592 and 50 artillery shells from area grid reference 3587 towards Pakistan positions in Kahuta sector.
- 4. On 25 April 1972, Indian troops fired five machine-gun bursts towards area grid reference 2681 in Kahuta sector.
- 5. On 25 April 1972, Indians were observed strengthening their defences by constructing bunkers in area grid references 567664 and 471714 in Chhamb sector.

- 6. On 26 April 1972, Indian troops fired 37 bombs of heavy mortar from area grid reference 8743 towards Pakistan positions in Lipa sector.
- 7. On 26 April 1972, Indians were observed digging in area grid references 6155, 6154 and 6059 in Chhamb sector.
- 8. On 26 April 1972, Indians were observed constructing bunkers in area grid reference 614568 in Chhamb sector.
- 9. At 0410 hours on 27 April 1972, Indian troops of approximately company strength supported by artillery and mortars attacked Pakistan platoon post at grid reference 941404 in Lipa sector.
- 10. On 27 April 1972, Indian troops fired intermittently with artillery mortars and machine-guns at Pakistan positions in area grid references 3293, 3393, 3294 and 2383 in Kahuta sector.
- 11. On 27 April 1972, Indian troops fired on civilians in area grid reference 204139 in Kotli sector.
- 12. On 28 April 1972, Indian troops fired approximately 15 bombs of mortar from area grid reference 9139 and 12 mombs of mortar from area grid reference 0218 towards Pakistan positions in Lipa-Pandu sector.
- 13. On 28 April 1972, Indians were observed constructing new bunkers in area grid references 232457 and 259364 in Kotli sector.
- 14. On 28 April 1972, Indian troops fired with machine-gun from area grid references 204136, 209139 and 202133 on Pakistan troops in Kotli sector.
- 15. On 28 April 1972, Indian troops fired three bombs of mortars towards Pakistan positions in area grid reference 0422 in Pandu sector.
- 16. On 29 April 1972, Indian troops fired with automatic weapons towards area grid references 5467, 5566 and 5567 in Chhamb sector.
- 17. On 30 April 1972, Indians were observed constructing bunkers in area grid reference 3299 in Hajira sector.
- 18. On 30 April 1972, Indians were observed constructing bunkers in area grid references 038642, 059645 and 069581 in Hajira sector.
- 19. On 30 April 1972, Indians fired intermittently with small arms, heavy mortars and artillery towards area grid references 3293, 3394, 3292, 2383 and 2384 in Kahuta sector.

- 20. On 30 April 1972, Indians were observed digging trenches, constructing bunkers in area grid references 614548, 596568, 601577, 617575, 601571, 599580, 536694, 535697, 59772, 598569 and 602577 in Chhamb sector.
- 21. At 1130 hours on 1 May 1972, Indian troops fired 12 bombs of heavy mortar from area Chota Kazi Nag grid reference 023189 in Pandu sector.
- $22.\,$ Between 1630 and 1730 hours on 1 May 1972, Indian troops fired 50 bombs of heavy mortar and artillery shells from area Jisla grid reference 3694 and Cali 3587 towards position in Kahuta sector.
- 23. On 1 May 1972, Indians were observed digging in area grid references 47913, 471714 and 474708 in Chhamb sector.
- 24. On 2 May 1972, Indian troops fired 80 bombs of heavy mortar and artillery shells from Jibla grid reference 3694 and Gali Maidan grid reference 3587 towards position in Kahuta sector.
- 25. On 2 May 1972, Indian troops fired five machine-gun bursts towards position in Hajira sector.
- 26. On 3 May 1972, Indian troops fired 30 bombs of heavy mortar and artillery shells from across Gidder post grid reference 2580 and Thanpir 2473 in Kahuta sector. They also fired approximately 160 bombs of mortar and artillery from Jibla grid reference 3694 and Gali Maidan 3587 towards area grid references 3293 and 3393 in the same sector.
- 27. On 3 May 1972, Indian troops fired approximately 40 bombs of heavy mortar and artillery from Jibla grid reference 3694 and Gali Maidan grid reference 3587 in Kahuta sector.
- 28. On 3 May 1972, Indian troops fired with machine-gun from area grid references 157111 and 157118 towards position in Kotli sector. Indians again fired intermittently approximately 180 rounds in the same sector.
- 29. On 4 May 1972, Indian troops attacked position in area grid reference 9735 with two companies. The attack was preceded by heavy mortar and artillery shelling in Lipa sector.
- 30. On 4 May 1972, Indians were observed constructing bunkers in area grid reference 127052 in Mirpur sector.
- 31. On 4 May 1972, Indians were observed digging crawl trenches in area grid references 6553 and 5958 in Chhamb sector.
- 32. On 4 May 1972, Indian troops fired approximately 200 artillery shells from Gali Maidan grid reference 3587 in Kahuta sector.

- 33. On 5 May 1972, an Indian patrol intruded into area grid reference 2581 in Kahuta sector.
- 34. On 5 May 1972, Indian troops fired 50 medium-gun shells from area Gali Maidan towards area grid references 3293 and 3393 in Kahuta sector.
- 35. On 5 May 1972, Indian troops fired with machine-gun, from area grid reference 212134 in Kotli sector.
- 36. on 6 May 1972, Indian troops fired with small arms and mortars in area grid references 2683 and 2783 in Kotli sector.
- 37. On 6 May 1972, Indians were observed digging in area grid references 481742, 533696, 585593 and 657538 in Chhamb sector.
- 38. On 6 May 1972, Indian troops fired intermittently with small arms and dropped approximately 130 bombs of heavy mortar and artillery in area grid references 1613, 1713, 1615 and 2217 in Kotli sector.
- 39. On 7 May 1972, an Indian patrol intruded into area grid reference 943393 in Tithwal sector. When engaged by Pakistan troops they withdrew but shelled area grid references 9238, 9339 and 9440.
- 40. On 7 May 1972, Indian troops fired with mortars and machine-gun from area Doda grid reference 2782 in Kahuta sector.
- 41. On 7 May 1972, Indian troops fired intermittently 200 bombs of mortars from area Jhangar grid references 1506 and 2209 in Kotli sector.
- 42. On 7 May 1972, Indian soldiers were observed digging in area grid references 474738, 483741, 482744, 658536 and 594577 in Chhamb sector.
- 43. On 7 May 1972, Indian soldiers were observed digging crawl trenches in area grid references 520712, 527716, 525715 and 611565 in Chhamb sector.
- 44. On 7 May 1972, Indian troops fired 17 machine-gun bursts from area Doda grid reference 2782 towards positions in Kahuta sector.
- 45. On 7 May 1972, Indian troops fired with recoilless rifles and machine-guns towards Pinjo grid references 162128, 158136, 196136 and 205143 in Kotli sector. Approximately 300 bombs of mortar and artillery were also dropped in area grid references 1615, 1613, 2015 and 2620 in the same sector.
- 46. On 8 May 1972, Indian troops fired intermittently with artillery and mortars from area grid references 1511, 1512, 1509 on positions in Kotli sector.

- 47. On 8 May 1972, Indian troops fired with automatic weapons from area grid references 558666, 559665, 559664 and 567663 on positions in Chhamb sector.
- 48. On 8 May 1972, Indian soldiers were observed digging in area grid references 6754, 598573, 527713 in Chhamb sector.
- 49. On 9 May 1972, Indian troops fired two machine-gun bursts from area grid reference 995155 on positions in Pandu sector.
- 50. On 9 May 1972, Indian troops fired 12 machine-gun bursts from area grid reference 274825 towards positions in Kahuta sector.
- 51. On 9 May 1972, Indian soldiers were observed constructing bunkers and digging in area grid references 286335, 293343, 305350, 267400, 232457 and 166114 in Kotli sector.
- 52. On 9 May 1972, Indian troops fired intermittently approximately 70 bombs of mortars, including incendiary bombs, in area grid references 2117, 1913, 1313 and 2319 in Kotli sector.
- 53. On 9 May 1972, Indian troops fired eight bombs mortars in area grid reference 1313 in Kotli sector.
- 54. On 9 May 1972, Indian soldiers were observed digging in area grid references 6553, 603568, 608552, 525715, 523714, 520712, 527716 and 520713 in Chhamb sector.
- 55. On 10 May 1972, Indian soldiers were observed constructing bunkers in area grid references 3491 and 3490 in Kahuta sector.
- 56. On 10 May 1972, Indian troops fired approximately 30 mortar bombs from area Doda grid reference 2881 and Gidder post 2580 in Kahuta sector.
- 57. On 10 May 1972, Indian soldiers were observed constructing bunkers in area grid reference 129037 in Hajipir sector.
- 58. On 10 May 1972, Indian troops fired with machine-gun from area grid reference 045636 towards position in Hajira sector.
- 59. On 10 May 1972, Indian troops fired approximately 300 rounds of machine-gun from area grid reference 204136 in Kotli sector.
- 60. On 10 May 1972, Indian soldiers were observed digging in area grid references 524715, 523714 and 533694 in Chhamb sector.
- 61. On 11 May 1972, Indian troops fired approximately five bursts of machine-gun on civilians in area grid reference 133104 in Kotli sector.

- 62. On 11 May 1972, Indian soldiers were observed digging in area grid references 6652 and 6653 in Chhamb sector.
- 63. On 11 May 1972, Indian troops fired twice at Pakistan observation post from area New Gatti post grid reference 609539 in Chhamb sector.
- 64. On 11 May 1972, Indian troops fired 25 rounds on civilians in area grid references 1310 and 2014 in Kotli sector.
- 65. On 12 May 1972, Indian troops fired six bursts machine-gun from area grid reference 274826 towards position in Kahuta sector.
- 66. On 12 May 1972, Indian troops fired intermittently with machine-gun and mortar towards position grid reference 1847 in Kotli sector. They also fired six bursts of machine-gun from area grid reference 1053 towards positions in the same sector.
- 67. On 12 May 1972, Indian troops fired machine-gun bursts from area grid reference 6055 at positions in Chhamb sector.
- 68. On 13 May 1972, Indian soldiers were observed constructing bunkers in area grid references 0501, 1203, and 1304 in Hajipir sector and in area grid references 2640, 2834, 1611 in Kotli sector.
- 69. On 13 May 1972, Indian troops fired with machine-gun intermittently from Chhati Tahli post grid reference 601556 and Gatti post 612532 at position in Chhamb sector.

SIALKOT SECTOR

- 1. On 29 April 1972, Indian troops fired with automatic weapons and rifles from area grid references 732264, 738264 and 745265 in Narowal-Maqbulpur sector.
- 2. On 30 April 1972, Indian troops fired few rifle shots and light-machine-gun bursts from area grid reference 7527, and on 1 May 1972, again fired with the same weapons.
- 3. On 2 May 1972, Indian troops fired with rifle from area grid reference 739270 in Narowal sector.
- 4. On 3 May 1972, Indian troops fired rifle and automatic weapons twice from area grid references 733265 and 749261.
- 5. On 5 May 1972, Indian troops fired with rifle and automatic weapons from area grid references 727267 and 735200 in Maqboolpur sector.

LAHORE SECTOR

- 1. On 24 April 1972, Indian troops fired at Pakistan observation post from Chananwala gap grid reference 2455 in Bahawalnagar sector.
- 2. On 25 April 1972, Indians resumed construction of bunkers in area Chananwala gap grid reference 2456. When warned to stop work, they fired at Pakistan troops with mortars and small arms.
- 3. On 29 April 1972, Indian troops carried out unprovoked fire with rifle on Fakistan patrol position grid reference 271741 in Kanganpur sector.
- 4. On 30 April 1972, Indian troops fired few rifle shots and two machine-gun bursts in Kasur sector.
- 5. On 2 May 1972, Indian troops fired machine-gun bursts from area Khem Karan post on post in Kasur sector.
- 6. On 12 May 1972, an Indian patrol fired towards position from area grid reference 5813.

RAJISTHAN SECTOR

- 1. On 27 April 1972, Indian troops pushed across the cease-fire line, a Pakistan family belonging to Gadro Charan QG 6131. Harassment of Pakistanis in occupied territory still continues unabated.
- 2. On night 28/29 April 1972, Indian soldiers mounted on camels intruded in area QC 2936. They fled away when challenged, leaving their mounts behind.
