BELGIUM

From Mr. G. Kaeckenbeeck, Alternate

"I have the honour to inform you that the Belgian Government proposes Mr. Nisot, Envoy Extraordinary and Minister Plenipotentiary, and member of the permanent delegation of Belgium in New York, as a candidate for election to the Sub-Commission on Prevention of Discrimination and Protection of Minorities. FEDERAL PEOPLE'S REPUBLIC OF YUGOSLAVIA

"As representative of the Federal People's Republic of Yugoslavia on the <u>Commission</u> on Human Rights, I have the honour to propose Dr. Lavo Cermelj, a Yugoslav national, as a member of the Sub-Commission on Prevention of Discrimination and Protection of Minorities. I append his <u>curriculum vitae</u>.

Dr. Cermelj was born in 1889. He studied and obtained his doctorate at the University of Vienna. He was a high-school teacher until the outbreak of war. During the war he was held for a long time by the occupation authorities in a concentration camp on account of his patriotic attitude.

At the end of hostilities he was elected Vice-Chairman of the People's Executive Committee for the Adriatic Area of the People's Republic of Slovenia, and later appointed Director of the Department of Frontier Affairs.

After the war he became a member of the Institute for Questions relating to the Rights of Minorities, and, in the same capacity, scientific adviser to the University of Ljubljana. In 1946 he served as expert on the subject with the Yugoslav delegation to the Peace Conference.

Dr. Cermelj has so far published 31 scientific works, 12 of which deal with various minority questions."
