 - Page 15.11, second sentence: for "promoting" read "achieving in a progressive manner"

 - Subprogramme 2, Statistics, under "Indicators of achievement (a)": replace the words "Increased number of national statistical systems that are able" with "Increased number of national statistical systems, benefiting from ESCAP and Statistical Institute for Asia and the Pacific assistance, that are able"
 - Paragraph 15.18, first sentence: add the following text to the end of the sentence: "with cooperation from other ESCAP divisions."
 - Subprogramme 4, Trade and investment, under "Indicators of achievement (a) (ii)": delete the word in parentheses; under "Indicators of achievement (b)(i), (c) and (d)", delete the parentheses and add "and other" after "officials"
 - Paragraph 15.20: add the following text at the end of the paragraph: "ESCAP will collaborate with other entities and agencies in the United Nations system, other bilateral and multilateral agencies, regional, subregional and national intergovernmental, private-sector and civil society organizations and networks in Asia and the Pacific."
 - Subprogramme 5, Transport and tourism, under "Expected accomplishments of the Secretariat (a)", delete the words "and road safety issues"
 - Paragraph 15.23: add the following text at the end of the paragraph: "The subprogramme will accord priority to the special needs of least developed countries, landlocked developing countries, countries with economies in transition and small island developing States."
 - Subprogramme 6, Environment and sustainable development: replace the narrative with the new version contained in annex II.B
 - Subprogramme 7, Information, communication and space technology, under "Indicators of achievement (c)(i), (c)(ii) and (d)": replace indicators (c)(i) and (c)(ii) with new indicator (c)(i): "Percentage of policymakers and officials benefiting from activities of the Asian and Pacific Training Centre for Information and Communication Technology for Development who indicate that their level of competency has increased in the use of information and communication technology for socio-economic development"; indicator (d) should read: "Increased number of countries participating in technology

Strategy

15.24 The substantive responsibility for the subprogramme lies with the Environment and Sustainable Development Division. The strategic direction of the subprogramme derives mainly from the internationally agreed development goals, including those contained in the United Nations Millennium Declaration, the 2005 World Summit Outcome, the outcomes of the other related major United Nations conferences and international agreements since 1992 and the Johannesburg Plan of Implementation, the Shanghai Declaration, the outcome of the fifth Ministerial Conference on Environment and Development in Asia and the Pacific, 2005, and other relevant mandates.

15.24 (bis) The subprogramme will focus on using innovative and pragmatic approaches in promoting equitable and environmentally sustainable economic growth. In the area of energy, the subprogramme will promote energy security, improve energy efficiency, enhance utilization of new and renewable sources of energy and assist in further development of regional and subregional energy cooperation. In the area of water resources, the subprogramme will continue to concentrate on capacity-building in strategic planning to promote integrated water resources management, improved access to safe drinking water and water conservation. In the area of the environment, the subprogramme will focus on improving the environmental performance of major stakeholders and promoting effective regional and subregional collaboration in environmental protection. Regional cooperation will be strengthened for natural disaster management. The strategic focus will be on assisting members and associate members to develop and apply gender responsive policies and programmes, where appropriate, in particular towards attaining Millennium Development Goals 1 and 7. It will comprise closely interrelated sectoral projects and interdisciplinary activities implemented jointly with other divisions within the thematic areas of managing globalization, reducing poverty and addressing emerging social issues. The subprogramme will promote wider participation of all stakeholders, including the civil society, in regional and national decision-making processes relating to sustainable development. The subprogramme will accord priority to the special needs of least developed countries, landlocked developing countries, countries with economies in transition and small island developing States. It will also seek to collaborate with other United Nations agencies and international organizations in the development of tools and networks to support the foregoing projects and interdisciplinary activities.

Annex III

Proposed revisions to the proposed biennial programme plan of programme 10 (Trade and development), based on the comments of the Working Party on the Medium-term Plan and the Programme Budget

1. Reflecting the decision of the UNCTAD Working Party on the Medium-term Plan and the Programme Budget, the following amendments to the text are submitted.

Contents

Subprogramme 5

- 2. The title of the subprogramme and the section headings should read:
 - "Subprogramme 5. Africa, least developed countries and special programmes
 - A. Development of Africa
 - B. Least developed countries
 - C. Special programmes"

Overall orientation

- 3. After paragraph 10.2, insert new paragraph 10.3 as follows and renumber the rest of the paragraphs accordingly:
 - "10.3 The work of UNCTAD in its three pillars, namely, research and analysis, consensus-building and technical cooperation, will be strengthened. The independent analytical capacity of UNCTAD will be enhanced to ensure the high quality of research and analysis necessary to address key issues of importance to developing countries. The results of such analysis will support and reinforce its activities in consensus-building and technical cooperation."
- 4. Replace current paragraph 10.3 as follows:
 - "10.4 Among the main objectives of the programme emanating from the outcomes of UNCTAD XI, the examination of development strategies in a globalizing world economy, is the principle task of subprogramme 1. Subprogrammes 2 and 4 will aim to contribute to building productive capacities and international competitiveness, while subprogramme 3 and the trade facilitation component of subprogramme 4 will aim to contribute to assuring development gains from the international trading system and trade negotiations. Development strategies of countries in special situations will be covered under subprogramme 5, while the sectoral concerns of those countries will also be addressed by other subprogrammes. The analytical work on least developed countries will be more effectively mainstreamed. The integration of cross-cutting issues, such as South-South cooperation, poverty alleviation and the gender dimension, will receive the necessary consideration within the context of pursuing the foregoing objectives."

5. Replace current paragraph 10.6 as follows:

"10.7 In an effort to respond better to changing global demand and the required reform of the United Nations, UNCTAD will explore ways and means to contribute effectively to the work of the Peacebuilding Commission, with a view to integrating relevant countries, particularly post-conflict ones, in the global economy. UNCTAD will attempt first of all to take an organic approach that would enable it to address immediately and coherently issues of importance for developing countries facing the global challenges of today. The subprogramme for the development of Africa, least developed countries and countries in special situations, intends to strengthen the subprogramme by maximizing the synergies of research and policy analysis and by taking a coherent approach to the issues of concern to those countries. The issue of science and technology, sine qua non for development today, is addressed in an integrated manner across subprogrammes through a special organizational arrangement. That approach will be further applied to other areas in response to the evolving demands of developing countries facing the challenges of the modern economy. UNCTAD will also try to maximize its contribution by sharpening its role within the international development assistance community. It will focus on enhancing its intellectual contribution, which could be discharged through cooperative effort with other international organizations with greater country presence, or with such external entities as regional institutions, non-governmental organizations and the private sector. Furthermore, UNCTAD will more closely cooperate with other national and international think-tank-like institutions with a view to enhancing its research and analysis while maintaining its intellectual integrity and independence. Finally, it will strive to provide technical assistance in a more organized and streamlined fashion so as to better respond to the changing needs of beneficiaries."

Subprogramme 1 Globalization, interdependence and development

Expected accomplishments of the Secretariat

6. Replace accomplishment (d) as follows: "Improved policy and institutional environment and enhanced international cooperation in the development of the Palestinian economy by strengthening UNCTAD activities in this field through the provision of adequate resources".

Subprogramme 2 Investment, enterprise and technology

Expected accomplishments of the Secretariat

7. Replace accomplishment (c) as follows: "Improved opportunities for enterprises in developing countries and countries with economies in transition to enhance their competitiveness through effective policy and prudential regulation for expansion of the insurance sector, deepened linkages between domestic and foreign firms and better understanding of emerging issues in accounting and reporting standards, corporate responsibility, transparency and good corporate practices".

Indicators of achievement

8. Replace indicator (c) as follows: "(c) (i) Increased number of countries indicating that policy advice and technical assistance provided by UNCTAD were useful in the design of policies aimed at enhancing the competitiveness of their enterprises". Add new indicator (c) (ii) as follows: "(ii) Increased number of countries indicating effective policy advice and assistance provided by UNCTAD for improving insurance legislation, regulation and sector growth".

Strategy

9. Replace current paragraph 10.9 as follows:

The subprogramme is implemented under the responsibility of the Division on Investment, Technology and Enterprise Development. To achieve the objective of the subprogramme, the Division will aim to improve the understanding of issues and policy choices in international investment, enterprise development and technology transfer and will continue to strengthen its role as the major source of comprehensive information and analysis of international investment. It will focus on the development dimension of international investment and technology flows, the interface of global processes and national policymaking and the integration of investment, technology and enterprise-development policies. The Division will also aim to strengthen the capacity of developing countries, in particular the least developed countries, at their request, to formulate and implement integrated policies and to participate in discussions relating to international investment, to support efforts by developing countries to build productive capacities and to respond to technological and scientific changes through science and technology reviews, to promote the transfer of technology and innovation and, in the field of insurance, to increase the capacity of developing countries to effectively regulate and upgrade the insurance sector."

Subprogramme 3 International trade

Expected accomplishments of the Secretariat

10. Replace accomplishment (a) as follows: "Improved understanding and better ability of developing countries, including non-WTO members, to analyse, formulate and implement appropriate trade policies and strategies in international trade, the international trading system and trade negotiations and improved international trading environment, facilitating market access and entry conditions for developing countries' exports".

Indicators of achievement

- 11. Replace indicator (a) as follows: "Increased number of developing countries, including non-WTO members, actively participating in the international trading system".
- 12. Replace indicator (b) (ii) as follows: "Increased number of countries and factors covered by the Trade and Development Index".

13. Replace indicator (e) as follows: "Increased number of results-oriented actions taken by developing countries and the international community to enable developing countries to take advantage of trade and investment opportunities while promoting their sustainable development objectives in international discussions or through specific policy measures for them at the national, regional and international levels".

Strategy

14. Replace current paragraph 10.10 as follows:

The subprogramme is implemented under the responsibility of the Division on International Trade in Goods and Services and Commodities. To achieve its objectives, the subprogramme will focus on assisting developing countries and countries with economies in transition, at their request, in responding effectively to challenges and opportunities, thereby maximizing the gains from international trade, including South-South trade, in goods and services and from commodity sector development and trade. The evolution of the international trading system and trends in international trade from a development perspective will be monitored and analysed in order to help developing countries develop the capacity to participate effectively in trade negotiations and in dynamic and new sectors of world trade and to formulate relevant policies and strategies, with particular attention paid to the concerns of the least developed countries. The subprogramme will provide a forum for policy discussion and consensus-building on core and emerging issues of international trade, the international trading system and trade negotiations, commodities, trade in goods and services, and new and dynamic sectors of international trade so as to ensure enhanced and predictable market access for the exports of developing countries, support their efforts to build supply capacities, competitiveness and diversification and address adjustment challenges. Special emphasis will be placed on the elaboration or improvement of development benchmarks, including through the Trade and Development Index analytical framework, the identification and quantification of non-tariff barriers, the provision of support to South-South cooperation and trade preferences, WTO accession, dispute settlement, trade-related aspects of intellectual property rights and development, competition policies, environmental requirements and biotrade."

Subprogramme 4 Services infrastructure for development, trade efficiency and human resources development

Indicators of achievement

- 15. Renumber indicator (c) as "(c) (i)".
- 16. Add new indicator (c) (ii) as follows:

"(c) (ii) Number of government officials trained who consider that paragraph 166 courses (training courses on key issues on the international economic agenda) have significantly contributed to the understanding of key issues on the international economic agenda".

Strategy

17. Replace current paragraph 10.11 as follows:

The subprogramme is under the responsibility of the Division for Services Infrastructure for Development and Trade Efficiency. To achieve the objective, the Division will aim to promote access to and capacity to use information and knowledge. UNCTAD assistance to landlocked countries and their transit neighbours will be strengthened, especially policy advice on transit transport agreements and infrastructure. In particular, it will focus on trade-supporting services, including the strengthening of transport efficiency, trade facilitation and customs and legal frameworks; economic applications of information and communication technologies; and development of the capacity of trade and training institutions. It will pursue the objective by: (a) carrying out timely and forward-looking research and analysis; (b) formulating policy recommendations for appropriate development strategies at the national, regional and international levels; (c) fostering dialogue for consensusbuilding; (d) providing technical assistance upon request; (e) supporting the capacity of trade, transport and training institutions; and (f) strengthening, through increased in-house cooperation and further integration of the work of the train-for-trade programme, the virtual institute, the training courses on key issues on the international economic agenda and other new initiatives. The reports and documents prepared under the subprogramme will be widely disseminated in connection with the provision of advisory services, training and workshops at the national and international levels. Where appropriate, they will draw upon the knowledge gained through technical cooperation activities."

Subprogramme 5

- 18. Replace the title as follows: "Africa, least developed countries and special programmes".
- 19. Renumber subtitle A as subtitle B and name as follows: "Least developed countries".

Expected accomplishments of the Secretariat

20. Replace accomplishment (b) as follows: "(b) Better integration of trade policies and priorities in the national development plans through the Integrated Framework for Trade-Related Technical Assistance to Least Developed Countries and the building of capacities for country ownership and implementation of the Action Matrices of the enhanced Integrated Framework".

Indicators of achievement

21. Replace indicator (b) as follows: "(b) Increased number of countries making efforts to mainstream their trade policies and priorities into their national development plans as well as concrete implementation of the Action Matrices of the enhanced Integrated Framework".

Strategy

22. Replace current paragraph 10.12 as follows:

The subprogramme is under the responsibility of the Division for Africa, Least Developed Countries and Special Programmes. To achieve the objective, the Division will focus on improving human and institutional capabilities in the least developed countries by: carrying out research and policy analysis; making policy proposals based on such analysis; facilitating intergovernmental discussion on issues relating to the least developed countries, including the status of least developed countries and their smooth graduation; and providing technical assistance based on the specific needs of the countries concerned. The causes of decline in the share of the least developed countries in world trade and the linkages between trade, growth and poverty reduction will continue to be examined through the Least Developed Countries Report. UNCTAD technical cooperation activities will be coordinated, taking into account the specific needs of the least developed countries and through participation in the Integrated Framework for Trade-Related Technical Assistance to Least Developed Countries and the International Trade Centre/UNCTAD/WTO Joint Integrated Technical Assistance Programme. The subprogramme will thereby contribute to implementing the Brussels Programme of Action for the Least Developed Countries for the Decade 2001-2010."

23. Renumber subtitle B as subtitle A and name subtitle as follows: "Development of Africa".

Strategy

24. Replace current paragraph 10.13 as follows:

"10.13 The subprogramme is under the responsibility of the Division for Africa, Least Developed Countries and Special Programmes. The subprogramme will focus on analytical research to identify issues that have an impact on Africa's economic development and will play an advocacy role in promoting consensus in the international development community on the policy measures that best address Africa's development problems. It will contribute to a better understanding of coherence between international economic rules and national policies and development strategies. The research output will be linked closely to the provision of advisory services, training, workshops and lectures, with a view to strengthening capacity-building activities."

C. Special programmes

Expected accomplishments of the Secretariat

25. Replace accomplishment (a) as follows: "(a) Enhanced international cooperation to implement the Almaty Programme of Action: addressing the Special Needs of Landlocked Developing Countries within a New Global Framework for Transit Transport Cooperation for Landlocked and Transit Developing Countries, and to improve the effective participation of landlocked developing countries, as

well as other groups of countries mentioned in paragraph 33 of the São Paulo Consensus, in the global trading system".

Strategy

26. Replace current paragraph 10.14 as follows:

"10.15 The subprogramme is under the responsibility of the Division for Africa, Least Developed Countries and Special Programmes. To achieve the objective, the Division will focus on improving human and institutional capabilities in the countries concerned through research and policy analysis and technical assistance based on the specific needs of the countries concerned. The subprogramme will thereby contribute to the implementation of the Almaty Programme of Action: Addressing the Special Needs of Landlocked Developing Countries within a New Global Framework for Transit Transport Cooperation for Landlocked and Transit Developing Countries and the Barbados Programme of Action for the Sustainable Development of Small Island Developing States, including the outcome of its review at the international meeting held in Mauritius. The subprogramme, through mainstreaming, will enhance the work on structurally weak, vulnerable and small economies, as stated in paragraph 33 of the São Paulo Consensus."

Annex IV

Observation of and revisions to the proposed biennial programme plan of programme 13, International drug control, crime and terrorism prevention and criminal justice, as proposed by three delegations members of the Commission on Narcotic Drugs and the Commission on Crime Prevention and Criminal Justice

- 1. It was observed that the United Nations Office on Drugs and Crime was currently developing a medium-term strategy, including the identification of key results and the elaboration of performance indicators. In that regard, strong support was reiterated for that important exercise. The view was expressed that the Office's strategy and the proposed strategic framework for the period 2008-2009 should be mutually reinforcing. It was noted by one member State that the work of the Office in support of norms, standards and international conventions, as well as in the areas of research and analysis, should be emphasized.
- 2. Observations were also made concerning subprogrammes 1 and 3 as follows:
- (a) With regard to subprogramme 1, Research, analysis and advocacy, in particular expected accomplishment (b), it was proposed that consideration should be given to having "the extent of technical assistance granted" as a possible indicator of achievement;
- (b) As to subprogramme 3, Technical assistance and advice, its expected accomplishments (a), (b) and (c) and the related indicators of achievement, it was stated that "the observed increases in the number of countries are not due to technical assistance and advice by the United Nations Office on Drugs and Crime" and it was suggested that "perhaps the language of the indicators of achievement needs to reflect that increases are the result of technical assistance and advice provided by the United Nations Office on Drugs and Crime."
- 3. The wish was expressed to see a number of editorial and other changes to the proposed strategic framework, as follows:
 - (a) Overall orientation
 - (i) In paragraph 13.6, the beginning of the sentence until the colon should read, "The work programme of the United Nations Office on Drugs and Crime consists of";
 - (ii) Paragraph 13.6 (a) should read, "Research and analytical work to increase knowledge and understanding of drug and crime issues and to expand the evidence base for making policy and operational decisions";
 - (b) Subprogramme 1, Research, analysis and advocacy
 - (i) Delete references to terrorism in the subprogramme;
 - (c) Subprogramme 2, Services for policymaking and treaty adherence
 - (i) Replace the objective of the Organization with the following text: "to facilitate policymaking on the issues related to drug control and crime in all its forms and manifestations and the ratification of and compliance with related drug control, crime and terrorism treaties ..." The reference to terrorism at the beginning of the objective is deleted, as that is the mandate of the Counter-

Terrorism Committee, with support from the Counter-Terrorism Committee Executive Directorate;

- (ii) Delete references to "prevention of terrorism" in the indicators of achievement;
- (d) Subprogramme 3, Technical assistance and advice
- (i) Expected accomplishment (d) should read, "Reduction in illicit crop cultivation through alternative development, sustainable livelihoods and credible law enforcement programmes";
- (ii) Indicator of achievement (d) should read, "Increased access of affected countries to advisory services and technical assistance for integrated alternative development programmes, including comprehensive alternative development".
