

May I also draw your attention to the relevant parts of sections IV and V of the report, concerning the agenda of the Main Committees.

Allocation of items to the Second Committee

1. Election of the officers of the Main Committees [item 5].

[In accordance with resolution 58/208 of 23 December 2003 and resolution 60/227 of 23 December 2005, the General Assembly will hold the High-level Dialogue on International Migration and Development in New York on 14 and 15 September 2006.]

- (d) Preventing and combating corrupt practices and transfer of assets of illicit origin and returning such assets, in particular to the countries of origin, consistent with the United Nations Convention against Corruption;

[In accordance with resolution 59/244 of 22 December 2004 and decision 60/556 of 16 May 2006, the General Assembly will convene the high-level meeting on the midterm comprehensive global review of the Programme of Action for the Least Developed Countries for the Decade 2001-2010 in New York on 18 September 2006, from 10 a.m. to 1 p.m. and from 3 p.m. to 6 p.m., as well as on 19 September 2006, from 9 a.m. to 10 a.m.]

- (b) Specific actions related to the particular needs and problems of landlocked developing countries: outcome of the International Ministerial Conference of Landlocked and Transit Developing Countries and Donor Countries and International Financial and Development Institutions on Transit Transport Cooperation.
- 10. Eradication of poverty and other development issues [item 57]:
 - (a) Implementation of the first United Nations Decade for the Eradication of Poverty (1997-2006);

[In accordance with resolution 59/246 of 22 December 2004, the General Assembly will devote one plenary meeting at its sixty-first session to the consideration of the outcome of and follow-up to the International Year of Microcredit, with a view to broadening and deepening the discussion about microcredit and microfinance.]

[The General Assembly decided that the report of the Administrator of the United Nations Development Programme on the operations, management and budget of the United Nations Development Fund for Women be referred to the Second Committee for consideration under item 58 (Operational activities for development).]

 - (a) United Nations University;
 - (b) United Nations Institute for Training and Research.

E. Effective coordination of humanitarian assistance efforts

- 13. Strengthening of the coordination of humanitarian and disaster relief assistance of the United Nations, including special economic assistance [item 69]:
 - (b) Special economic assistance to individual countries or regions;
 - (c) Participation of volunteers, "White Helmets", in the activities of the United Nations in the field of humanitarian relief, rehabilitation and technical cooperation for development.

[The General Assembly decided to allocate item 118 also to all the Main Committees and the plenary of the General Assembly to enhance discussion of evaluation, planning, budgeting and monitoring reports.]
