

Letter dated 15 September 2006 from the Permanent Representatives of Estonia, Latvia and Lithuania to the United Nations addressed to the President of the Security Council

We have the honour to address you as President of the Security Council for the month of September in the matter of the selection of the next Secretary-General.

Upon the instructions of our respective Governments, we wish to submit for consideration by the Security Council for the post of Secretary-General the candidature of the President of the Republic of Latvia, Vaira Vīķe-Freiberga.

The President of Latvia has been Head of State since 1999, in which time she has gained extensive experience in global affairs. Coming from a relatively small country which has recently undergone the transition from totalitarian rule to freedom and democracy, the President highly values the role of multilateral diplomacy in preventing and minimizing threats to global peace, security and prosperity.

The President of Latvia has proved the capacity of a woman to lead and inspire a nation. The favourable consideration of President Vaira Vīķe-Freiberga for the post of Secretary-General would be a tangible demonstration of the principle of gender equality, so tirelessly defended by the United Nations over the past 60 years.

Biographical details of the President of the Republic of Latvia

Vaira Vīķe-Freiberga

Professional career (1965-1999)

From 1965 to 1998 Vaira Vīķe-Freiberga was a professor at the Department of Psychology of the French-speaking University of Montreal. She taught psychopharmacology, psycholinguistics, scientific theories, experimental methods, language and cognitive processes. Her experimental research, supported by grants from the National Sciences and Engineering Research Council of Canada (NSERC), focused on memory processes and language, and the influence of drugs on cognitive processes. She has supervised the theses of many Master's and Doctoral students.

At the same time she did scholarly research on semiotics, poetics and the structural analysis of computer-accessible texts from an oral tradition — the Latvian folksongs (*Dainas*). Her research (jointly with her husband, informatics professor Imants Freibergs) was supported by grants from the Social Science and Humanities Research Council of Canada (SSHRC). Together they published a book and a database on the Latvian Sun-songs in 1988.

During this period she authored nine books and about 160 articles, essays or book chapters and has given over 250 speeches, allocutions and scientific communications in English, French or Latvian. Some articles have been translated into Swedish, Polish, Russian, German and Lithuanian. She gave numerous radio, TV and press interviews in various languages. Vaira Vīķe-Freiberga is a member of the Writers' Union of Latvia (2004).

Since 1957, Dr. Vīķe-Freiberga has been actively engaged in community service, focusing on questions of Latvian identity and culture, and the political future of the Baltic States. She became a specialist of Latvian folklore and encouraged young Latvians to learn about their cultural heritage. She has been a lecturer, director and president of the Board of Directors of the Latvian Cultural Heritage Seminars for university-level participants (1965-85) and subsequently for families, in North and South America, Europe and Australia. A renowned public speaker, she was regularly invited to cultural and social events and published many articles on these questions in Latvian, English and French.

Presidency of the Republic of Latvia (since 1999)

On 17 June 1999, Prof. Vaira Vīķe-Freiberga was elected President of the Republic of Latvia by the Parliament (*Saelma*) and was sworn in on 8 July. In 2003 she was re-elected for a second term of four years with 88 votes out of 96.

She was named Special Envoy to the Secretary-General on the reform of the United Nations in 2005.

Member of the Council of Women World Leaders since 1999.

Powers exercised by the President

- The power to name the Prime Minister (exercised five times so far).
- The President is Commander-in-Chief of the armed forces of Latvia and names the Commander of the armed forces.
- Legislative powers: she has initiated and submitted to Parliament the law to institute the Office of Ombudsman, the law on State awards and decorations, initiated several changes to the Criminal code and has collaborated with parliamentary commissions in drafting many other laws.
- The right to veto: The possibility to return any law passed by the Parliament with a reasoned request for reconsideration. This veto has been exercised on over twenty occasions, thus ensuring better quality legislation (laws on language, commerce, public organisations, elections, municipal budgets, sales of alcoholic beverages, to name a few).
- The right to grant clemency to criminals. As Head of the Clemency Board, the President regularly examines requests for clemency (over 100 each year) and has reduced prison terms in dozens of cases.
- The President heads the National Security Council, the Military Council, and the Commission on State Awards (until 2004).
- A number of Commissions operate under the auspices of the President: on strategic analysis, on the state language, on state awards and heraldry, the International Commission of Historians, the Commission on State Awards (since 2004).
- The President meets regularly with the Prime Minister, Cabinet Ministers, mayors and officials of municipalities, heads of government departments and agencies, as well as members of civil society to focus on functional or actual problems and solutions under their jurisdiction.
- The President regularly visits towns and villages to meet the population in person, to familiarize herself with their social situation and to listen to their concerns. She also receives many thousands of letters yearly from the inhabitants

• The President has been outspoken regarding a number of social causes (reform of the Justice system, children's rights, women's rights, prisoners' rights, drug trafficking, corruption, etc.) and has agreed to patronise various non-governmental cultural, social, and sports organisations and events.
