Statement by the Council of Ministers for Foreign Affairs of the member countries of the Organization for Democracy and Economic Development — GUAM concerning the "referendum" in the Transnistrian region of the Republic of Moldova

The Ministers for Foreign Affairs of the member countries of the Organization for Democracy and Economic Development — GUAM (Georgia, Ukraine, the Republic of Azerbaijan and the Republic of Moldova) have firmly rejected the so-called "referendum" held on 17 September 2006 in the Transnistrian region of the Republic of Moldova and its results, which have no legal consequences from the standpoint of international law.

This "referendum" is illegal and its results cannot be recognized since they violate the internationally recognized sovereignty and territorial integrity of the Republic of Moldova and the principles and purposes of the United Nations and the Organization for Security and Cooperation in Europe (OSCE) in this sphere, and do not contribute to a settlement of the Transnistrian conflict.

The situation in which the "referendum" was held did not meet universally recognized democratic standards and cannot be regarded as the freely expressed will of the population of the Transnistrian region of the Republic of Moldova.

In this regard, the Ministers for Foreign Affairs of the member countries of GUAM endorse the statements by the European Union, the Chairman-in-Office of OSCE, the Committee of Ministers of the Council of Europe and a number of States rejecting the results of the "referendum".

The international community has once again confirmed that a settlement of the Transnistrian conflict is possible only through preservation of the sovereignty and territorial integrity of the Republic of Moldova and also respect for the rights and freedoms of the population on both banks of the Dniester river.

The Ministers for Foreign Affairs of the member countries of GUAM call upon the participants in the "5+2" negotiating process to return to the negotiating table as soon as possible and make all necessary efforts to find a final and just solution to the Transnistrian conflict in accordance with international standards and earlier agreements.
