

Report of the Second Committee*

1. At its 2nd plenary meeting, on 13 September 2006, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-first session the item entitled:

"Sustainable development:

- "(a) Implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21 and the outcomes of the World Summit on Sustainable Development;
- "(b) Follow-up to and implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States;
- "(c) International Strategy for Disaster Reduction;
- "(d) Protection of global climate for present and future generations of mankind:
- "(e) Implementation of the United Nations Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, Particularly in Africa;
- "(f) Convention on Biological Diversity;
- "(g) Report of the Governing Council of the United Nations Environment Programme on its ninth special session;"

and to allocate it to the Second Committee.

2. The Second Committee considered the item at its 19th to 23rd meetings, on 25, 26 and 30 October 2006. An account of the Committee's discussion of the item is

At the 19th meeting, on 25 October, introductory statements were made by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs (under sub-items (a) and (b)); the Under-Secretary-General for Humanitarian Affairs and Emergency Relief Coordinator (under sub-item (c)); the Executive Secretary of the United Nations Framework Convention on Climate Change (under sub-item (d)); the Executive Secretary of the United Nations Convention on Biological Diversity (under sub-item (f)); and the representative of the United Nations Environment Programme (under sub-item (g)) (see A/C.2/61/SR.19).
- 5. At the 20th meeting, on 25 October, the Under-Secretary-General and High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States made a statement (see A/C.2/61/SR.20).
- 6. At the 23rd meeting, on 30 October, an introductory statement was made by the Executive Secretary of the United Nations Convention to Combat Desertification (under sub-item (e)) (see A/C.2/61/SR.23).
- 7. At the same meeting, pursuant to section C, paragraph 3 (d), of the annex to General Assembly resolution 58/316, the Committee held a dialogue with the Executive Secretary of the United Nations Convention to Combat Desertification, and comments were made and questions posed by the representatives of Venezuela (Bolivarian Republic of), Nigeria and Somalia (see A/C.2/61/SR.23).
