**DRAFT DECISION ON  
FINANCIAL ARRANGEMENTS**

*The Meeting of the Parties,*

*Recalling* article 17, paragraph 2 (h), of the Protocol, which states that the Meeting of the Parties shall consider establishing financial arrangements by consensus and technical assistance mechanisms to facilitate the implementation of this Protocol,

*Recalling also* article 21, which stipulates that the Executive Secretary of the Economic Commission for Europe shall carry out secretariat functions,

*Recalling further* its decisions [I/. and I/.] on the procedures for the preparation, adoption and monitoring of work programmes and on the work programme for [2008–2009],

*Recognizing* that effective implementation of the Protocol depends, *inter alia*, on the availability of sufficient financial and human resources,

*Believing* that the need for stable and predictable sources of funding and a fair sharing of the burden should be the guiding principles of any financial arrangements established under the Protocol,

*Determined* to ensure that the necessary resources are available for implementing the core elements of the work programme,

*Believing* that a voluntary scheme of contributions by Parties and other States or regional economic integration organizations, [based upon a system of equal shares,] can provide an effective and workable solution,

*Convinced* that the levels of contributions should be based upon [the United Nations scale of assessments or other][an] appropriate scale[s] of assessment, and that consideration should be given to establishing stable and predictable financial arrangements,

1. *Establishes* an interim voluntary scheme of contributions to be sustained by contributions from Parties, Signatories and other States having opted to participate in the scheme;
2. *Recognizes* that activities under the work programme for [2008–2009] not covered by the United Nations regular budget should be covered by voluntary contributions based on a differentiated system of shares, as follows:
  - (i) Type A of US\$ 20,000; and
  - (ii) Type B of US\$ 500,

whereby Parties, Signatories and other States having opted to participate in the scheme would be able to contribute one or more shares, or parts thereof, from either of the two types, including in combination;

3. *Invites* Parties, Signatories and other States in a position to do so to contribute, in cash or in kind, an amount corresponding to one or more shares or parts thereof, especially to core activities identified in the work programme. No contribution should be less than US\$ 200;
4. *Welcomes* the participation in the scheme of those Parties, Signatories and other States not Party to the Protocol that have pledged contributions and any additional contributions towards activities under the work programme of the Protocol;
5. *Requests* that [all] such contributions in cash be made to the UNECE Trust Fund on Local Technical Cooperation (Project: Protocol on PRTRs)

6. *Endorses* the guiding principles for financial assistance to support the participation of experts and representatives from countries with economies in transition in meetings and workshops organized within the framework of the Protocol and other relevant activities established and periodically updated by the Committee on Environmental Policy, while recognizing that the provision of any financial support is subject to the availability of funds;
7. *Requests* the secretariat, in accordance with the financial rules of the United Nations, to monitor the expenditure of the funds and to prepare a report to the next session of the Meeting of the Parties as well as annual reports to the [Bureau] [NAME OF MAIN INTERSESSIONAL BODY] in the interim years, in order to ensure that the level of contributions matches the level of funding needed for the implementation of the work programme, and including information on how much Parties and other participating States contributed to the budget of the Protocol in cash [and in kind], and on how the contributions were spent;
8. [*Also requests* the [Bureau] [NAME OF MAIN INTERSESSIONAL BODY] to:
  - (a) Consider, in the light of these annual reports, whether changes would be required to the content or time frame of the work programme in the event that the level of actual and/or pledged contributions does not match the level of funding needed;
  - (b) Consider the feasibility of and modalities for introducing a system of financial arrangements based on the United Nations scale of assessments or other appropriate scales;
  - (c) Explore the possibility of establishing stable and predictable financial arrangements with a view to their possible adoption at the second session of the ordinary meeting of the Parties; and
  - (d) Explore the implications of allowing in-kind contributions, such as might be contributed for projects undertaken within the context of the framework programme on capacity-building [or to a separate technical assistance mechanism], to be counted within a State's overall contribution;]
9. *Agrees* to review the question of financial arrangements at its second ordinary session, on the basis of the work and any proposals of the Working Group of the Parties.
