# Item 1 Organizational matters

In accordance with Executive Board decision 2006/14 and rule 7 of the Rules of Procedure of the Executive Board of UNDP and UNFPA, the Board will elect a new Bureau consisting of a President and four Vice-Presidents. The election will take place on 11 January 2007. According to the established pattern of rotation of posts among the various regional groups, the President of the Executive Board for 2007 should be elected from the Board members of the Western European and other States group.

Under this item, the Executive Board will adopt the agenda and agree on the work plan for the session as presented by the Secretary of the Board. The Board will also approve the report of its second regular session 2006. A draft report was distributed to Board members for their comments; the final report contains comments received within the deadline.

In accordance with decision 96/25, a work plan for 2007 was prepared by the secretariat in close consultation with the Bureau of the Board and is submitted to the Board for adoption.

# Item 2 UNDP strategic plan, 2008-2011

In response to Executive Board decision 2006/1, UNDP will present for discussion and guidance from the members of the Executive Board its initial thinking, as outlined in the strategic note, with respect to the formulation of a strategic plan 2008-2011, including the programming arrangements and results-based support budget that will underpin the implementation of the plan.

# Item 3 Programming arrangements

In its decisions 2002/18 and 2005/26, the Executive Board requested UNDP to undertake an assessment of the current programming arrangements as part of its preparation for the next programming period (2008-2011). The Board has also requested UNDP to submit, in the context of the preparations of the 2008-2011 strategic plan, a proposal for synchronization of the processes leading to the endorsement of future strategic plans and programme financial frameworks.

As the review is being undertaken in a dynamic and changing development within the United Nations as a whole and UNDP in particular, the present report focuses on assessment of the existing arrangements. Options for the future funding framework for regular resources, 2008-2011, will be presented and discussed under agenda item 2.

# Item 4 Country programmes and related matters

As requested by the Executive Board in its decision 2001/11, the following country programmes will be approved on a no-objection basis without presentation or discussion, unless at least five members have informed the secretariat in writing before the meeting of their wish to bring a particular country programme before the Board:

Africa region: Central African Republic, Eritrea, Ethiopia, Gabon, Gambia, Guinea, Mozambique, Sao Tome and Principe, Senegal, Seychelles, South Africa, Tanzania, Zambia and Zimbabwe;

Arab States region: Algeria, Egypt, Morocco, Saudi Arabia, Somalia, the Syrian Arab Republic, Tunisia and Yemen;

Asia and the Pacific region: the Democratic People's Republic of Korea, the Lao People's Democratic Republic, Mongolia and Thailand;

Europe and the Commonwealth of Independent States region: Croatia, the Republic of Moldova, the Republic of Montenegro;

Latin America and the Caribbean region: Belize, Brazil, Chile, the Dominican Republic, El Salvador, Honduras, Jamaica, Panama, Paraguay and Uruguay.

## Item 5 Evaluation

The evaluation of UNDP assistance to conflict-affected countries was conducted by the Evaluation Office in response to a request from the Executive Board. Focusing on the period 2000-2005, the evaluation assesses UNDP performance in terms of contribution to improving human security and addressing the structural conditions to prevent recurrence of armed conflict. The report takes into consideration the feedback obtained from Member States at an informal briefing on 9 October 2006. The executive summary presents the changing context of conflict around the globe, the key findings and recommendations related to the substantive capacity of UNDP to engage in peacebuilding and the need to integrate development efforts in United Nations strategies for security.

The evaluation of the national human development report (NHDR) system was undertaken by the Evaluation Office to assess the influence of NHDRs in programme countries and within UNDP. The evaluation focuses on the national human development reports as well as the system of networks, practices and processes involved in the production and dissemination of the NHDRs. The scope of evaluation addresses the following issues since the inception of NHDRs in 1992: (a) comparative advantage in promoting human development approaches; (b) strategic relevance and importance, (c) influence in programme countries and UNDP; and (d) sustainability. The executive summary presents the context of NHDRs, the key findings, and recommendations at the global and country levels.

A partnership agreement was signed by the UNDP Administrator and Director-General of the United Nations Industrial Development Organization (UNIDO) in 2004 to facilitate greater collaboration between the two organizations and to leverage UNDP strengths at the country level to strengthen UNIDO support to private sector development. An assessment at the end of the pilot phase (two years) was requested by the General Conference of UNIDO. The assessment was conducted jointly by UNDP and UNIDO evaluation offices. The report takes into consideration comments received from the Member States at briefings of the respective governing bodies.

## Item 6 Gender in UNDP

The progress report of the Administrator on the implementation of the gender action plan is submitted in compliance with Executive Board decision 2006/3. The report highlights key achievements made in 2006 in implementing the gender action plan 2006-2007, with particular reference to the operationalization of the Administrator's Gender Steering and Implementation Committee, investments of \$10 million for implementing the gender action plan, 2006-2007, the one-week gender event featuring UNDP success stories on gender mainstreaming around the world and UNDP facilitation of country reports to the Committee on the Elimination of Discrimination against Women.

The follow-up report of the Administrator on the Organizational Assessment of the United Nations Development Fund for Women (UNIFEM) is submitted in compliance with Board decision 2006/5, whereby the Administrator was requested "to take steps to ensure that UNIFEM gains access to relevant United Nations forums in order to better achieve its contribution to United Nations objectives in gender equality and women's empowerment". Special efforts have been also undertaken to clarify the roles and responsibilities of UNDP and UNIFEM in the context of the establishment of a new gender entity.

The Executive Board may wish to commend the progress achieved in the implementation of the gender action plan and welcome the clarification of the roles and responsibilities of UNDP and UNIFEM in promoting gender equality and women's empowerment.

# Item 7 United Nations Capital Development Fund

The present document is prepared in response to Executive Board decisions 2006/4 and 2006/15. It sets forth the status of the discussions between UNDP and the United Nations Capital Development Fund (UNCDF) with respect to the development of their strategic, operational and financial partnership as well as a framework for cooperating and working together more closely within the context of the UNDP strategic plan. The document outlines the direction and approach the two organizations have taken, notably toward integrating UNCDF's contributions in its local development and microfinance practice areas into UNDP's strategic plan for 2008-2011. The document reflects the fact that much work remains to be done in the coming months, after which

UNDP and UNCDF will be able to report in detail on their partnership at the annual session 2007.
