Elections, nominations, confirmations and appointments to subsidiary and related bodies of the Economic and Social Council

At its 45th meeting, on 30 November 2006, the Economic and Social Council took the following action with regard to vacancies in its subsidiary and related bodies:

The Council elected Zhan Daode (China) for a term beginning on the date of election and expiring on 31 December 2008, to fill a vacancy arising from the resignation of Yongxiang Shen.

The Council further postponed the election of one member from the Group of Asian States and one member from the Group of Western European and Other States for a term beginning at the first meeting of the Commission's forty-first session, in 2007, and expiring at the close of its forty-fourth session, in 2011.

Commission on Science and Technology for Development

The Council elected **Belgium** and **Turkey** by acclamation for a four-year term beginning on 1 January 2007.

Executive Board of the International Research and Training Institute for the Advancement of Women

The Council elected **Israel**, the **Philippines** and the **Syrian Arab Republic** by acclamation for a three-year term beginning on 1 January 2007.

The Council further postponed the election of two members from the Group of African States and two members from the Group of Eastern European States for a three-year term beginning on 1 January 2007.

Committee for the United Nations Population Award

The Council elected the **Czech Republic**, **Lesotho** and **Malaysia** by acclamation for a three-year term beginning on 1 January 2007.

The Council further postponed the election of two members from the Group of African States for a three-year term beginning on 1 January 2007.

Governing Council of the United Nations Human Settlements Programme

The Council elected **Italy** by acclamation for a four-year term beginning on 1 January 2007.

The Council further postponed the election of three members from the Group of Latin American and Caribbean States for a four-year term beginning on 1 January 2007.

Committee on Economic, Social and Cultural Rights

The Council elected Barbara Wilson (Switzerland) by acclamation for a term beginning 1 January 2007 and expiring on 31 December 2008, to fill a vacancy arising from the resignation of Giorgio Malinverni (Switzerland).

Executive Board of the United Nations Development Programme/United Nations Population Fund

The Council elected **Denmark** for a term beginning on 1 January 2007 and expiring on 31 December 2009, to fill a vacancy arising from the resignation of Sweden.

Organizational Committee of the Peacebuilding Commission

The Council elected the **Czech Republic** and re-elected **Indonesia** for a term beginning on 1 January 2007 and expiring on 22 June 2008, to fill vacancies arising from the expiration of the terms of two members of the Economic and Social Council (Poland and Indonesia) that were elected to the Organizational Committee.

The Council postponed the election of one member from the Group of Western European and Other States for a term beginning on 1 January 2007 and expiring on 22 June 2008 to replace Belgium, whose term as a member of the Economic and Social Council expired on 31 December 2006.

Application of the intergovernmental organization International Emergency Management Organization, for observer status with the Economic and Social Council

At its 48th meeting, on 15 December 2006, the Economic and Social Council decided to defer to its organizational session for 2007 consideration of the application for observer status of the intergovernmental organization International Emergency Management Organization.

2006/265

Inclusion of Papua New Guinea in the list of least developed countries

At its 48th meeting, on 15 December 2006, the Economic and Social Council, taking note of recommendation 1 contained in the report of the Committee for Development Policy on its eighth session⁶ that Papua New Guinea be included in the list of least developed countries (subject to acceptance by the Government), and also taking note of the letter dated 21 July 2006⁷ from the Permanent Representative of Papua New Guinea to the United Nations addressed to the Secretariat, decided to defer consideration of the Committee's recommendation to the Council's substantive session of 2007.

Recommendation contained in the report of the Committee for Development Policy on its eighth session concerning Samoa

Enlargement of the Commission on Science and Technology for Development

At its 48th meeting, on 15 December 2006, the Economic and Social Council, recalling its resolution 2006/46 of 28 July 2006, in which it decided, inter alia, that the Commission on Science and Technology for Development should be enlarged by the inclusion of ten new members:

- (a) Decided that the distribution of the ten new seats on the Commission will be as follows:
 - (i) Three seats for the Group of African States;

- (c) Further decided that the elections of the ten new members of the Commission would be held at the organizational session of the Council in February 2007.

At its 48th meeting, on 15 December 2006, the Council decided to take note of the report of the Permanent Forum on Indigenous Issues on its fifth session.⁹

2006/274

Follow-up to the implementation of General Assembly resolution 61/16 on the strengthening of the Economic and Social Council

At its 48th meeting, on 15 December 2006, the Economic and Social Council decided:

- (a) To defer consideration of the focus of its 2007 thematic discussion and the theme for its 2007 annual ministerial review to the first meeting of its organizational session for 2007;
- (b) To devote consideration of the theme "The role of the United Nations system in promoting full and productive employment and decent work for all" at the coordination segment of its substantive session of 2007;
- (c) To approve the contributions of relevant subsidiary bodies of the Economic and Social Council, including functional and regional commissions, and the organizations of the United Nations system to the annual ministerial-level substantive review and the Development Cooperation Forum as follows:
 - (i) Decides, in accordance with paragraph 8, on annual ministerial-level substantive reviews, of General Assembly resolution 61/16 of 20 November 2006:

- a. To urge its functional commissions and other relevant subsidiary bodies and follow-up mechanisms, as appropriate, to contribute, in accordance with their mandates and taking into account their specificity, to the assessment;
- b. To invite the organizations of the United Nations system, including the Bretton Woods institutions and the World Trade Organization, to contribute within their respective mandates to the consideration by the Council;
- (ii) Also decides, in accordance with paragraph 9 of General Assembly resolution 61/16, to urge the regional commissions, in collaboration with other regional and subregional organizations and processes, as appropriate, to contribute, within their mandates, to the review of progress made in the implementation of and follow-up to the outcomes of the major United Nations conferences and summits in the economic, social and related fields and to provide input to the discussions of the Economic and Social Council in accordance with its rules of procedure;
- (iii) Further decides that this decision should apply to the first annual ministerial-level substantive review and the Development Cooperation Forum to be held in 2007, without prejudice to the future modalities of interaction between the Economic and Social Council and its subsidiary bodies beyond the substantive session of 2007 of the Council.
