#### **Annotations**

#### 1. Election of officers

In accordance with rule 18 of the rules of procedure of the Economic and Social Council, each year, at the commencement of its first meeting, the Committee elects its Chairperson and four Vice-Chairpersons. In accordance with rule 19, Bureau members are eligible for re-election. One of the Vice-Chairpersons is later designated also to serve as Rapporteur.

#### 2. Adoption of the agenda and other organizational matters

In accordance with rule 13 of the rules of procedure of the Council, the Committee shall, at the beginning of each session, after the election of its officers, adopt the agenda for that session on the basis of the provisional agenda. The provisional agenda for the current session was approved by the Council in its decision 2006/226.
