The Working Group on Strategies and Review is expected to continue its work on the review of the 1999 Gothenburg Protocol, including progress in reducing acidification, eutrophication and ground-level ozone and the pollutants responsible for these effects. The Working Group will have before it a first draft of the report on the review of the Protocol. The Working Group is expected to discuss the document and provide guidance for further work with a view to finalizing the report at its fortieth session in September 2007.

The delegations of Canada and the United States will present updated information on their activities in support of the review of the Gothenburg Protocol. The delegation of Sweden will inform the Working Group about those results of the Workshop on Air Pollution and Its Relation to Climate Change and Sustainable Development, being held on 12–14 March 2007 in Gothenburg (Sweden), which are relevant to the review of the Gothenburg Protocol.

The Working Group will also have before it the report of the tenth meeting of the Expert Group on Techno-economic Issues, held in November 2006 in Marseilles (France), and a report on the results of the Workshop on Atmospheric Ammonia, held in December 2006 in Edinburgh (United Kingdom).

The Working Group is expected to discuss the options presented in the document prepared by the secretariat in consultation with the EMEP Bureau and to provide guidance.

The Working Group is expected to consider the executive summary prepared by the secretariat and to make recommendations.

The Executive Body, at its twenty-fourth session, invited the Working Group to consider, on the basis of the report of the ad hoc group of legal experts, the possibility of an expedited procedure, including in combination with existing procedures, for amending the annexes to the Protocol, and, if appropriate, to request the ad hoc group to submit a further report to the Working Group for consideration. The Working Group is expected to consider the options presented in a note by the ad hoc group and to agree on recommendations to be forwarded to the twenty-fifth session of the Executive Body.
