In accordance with article 7 of the Statute of the International Court of Justice, the Secretary-General has the honour to submit to the General Assembly and to the Security Council a list in alphabetical order of the candidates nominated by national groups for the election to be held during the forthcoming regular session of the General Assembly in order to elect five judges to succeed Judges Sir Arnold Duncan McNair (United Kingdom), José Gustavo Guerrero (El Salvador), Alejandro Alvarez (Chile), Jules Basdevant (France), and Levi Fernandes Carneiro (Brazil), whose terms of office are due to expire on 5 February 1955.

Curricula vitae of the candidates are included in this document, with the exception of those which have already been published in document A/2668 - S/3270, concerning the election of a member of the Court to fill the vacancy caused by the death of Sir Benegal Rau.

ALFARO, Ricardo J.

Panamanian jurist and statesman.

Born at Panama, 1882; attended baccalaureate course at University of Cartagena, Colombia; Doctor of Laws and Political Sciences of the National Faculty of Panama; Doctor of Laws honoris causa of the University of Southern California, Los Angeles.

Posts held: Under-Secretary for Foreign Affairs, 1905-1908; Legal Counsellor of the Panamanian Legation in Washington, specially assigned to the Panama-Costa Rica frontier question, 1912; member of the Codification Commission of Panama responsible for drafting the Code of Judicial Procedure (organization, civil procedure and criminal procedure), 1913-1916; Judge of the Joint Commission established under the Convention of 1903 between Panama and the United States of America for the settlement by arbitration of claims in respect of expropriations for the construction of the Canal, 1915-1918; Professor of Civil Law at the National School of Law, 1917-1922; Professor of International Law at the University of Panama since 1948; Secretary of the Interior and Justice and on several occasions in charge of Foreign Affairs, 1918-1922; Envoy Extraordinary and Minister Plenipotentiary of Panama to the United States, 1922-1930 and 1933-1936; delegate to the Inter-American Commercial Aviation Commission and the International Conference on Radiotelegraphy, Washington, 1927; delegate plenipotentiary to the Sixth International Conference of American States at Havana, and Rapporteur on "Pacific Solution of International Conflicts", 1928;

# BASDEVANT, Jules

French jurist; Judge of the International Court of Justice.

Born in 1877; Doctor of Law (Legal, Political and Economic Sciences); agrégé of the Faculties of Law (Public Law) 1903; Professor of Law at the Faculties of Rennes and Grenoble, 1903-1918, and afterwards at the Faculty of Law of Paris; Professor at the Naval Staff College and at the Centre of Higher Naval Studies; at the Academy of International Law, The Hague; at the Free School of Political Science and, temporarily, at the School of Political Science, Jagellon University, Cracow; member of the Institute of International Law, of the Institut de France (Academy of Moral and Political Sciences); associate of the Académie royale de Belgique.

Legal adviser to the Ministry for Foreign Affairs; member of the French delegation at many international conferences (Peace Conference, 1919; International Private Law Conferences; London Naval Conference; Conference on the Codification of International Law; Conference for the Reduction and Limitation of Armaments; Conference for the Prevention of Terrorism; United Nations Committee of Jurists for the Preparation of a draft Statute of the International Court of Justice, Washington, April 1945; United Nations Conference on International Organization, San Francisco, April-June, 1945; and to the League of Nations Assembly).

Assembly of the United Nations; French Government delegate to International Red Cross Conferences (Brussels and London); member of various legal committees set up by the League of Nations, the Institute for the Unification of Private Law and the International Committee of the Red Cross.

Agent of the French Government in many international arbitrations, and, since 1923, before the Permanent Court of International Justice; member of the Permanent Court of Arbitration; presented as a candidate by several national groups in 1939 for election to the Permanent Court of International Justice (the elect. 1 did not take place, owing to the political situation).

Elected a judge of the International Court of Justice, 1946; Vice-President of the Court, 1946-1949; President of the Court, 1949-1952.

# CARDAHI, Choucri

Lebanese jurist.

Born at Beirut, 1890; studied law at the Faculties of Law of Aix-Marseilles and Paris; practised in the Egyptian mixed courts, 1911-1920; appointed professor at the French school of law at Beirut, 1920, and combined his work there with judicial duties in Lebanon; Counsellor to the Court of Cassation, 1922; First President of the Court of Cassation, 1934; Minister of Justice, 1927 and 1928 (drew up bill on judicial organization and took the initiative in the preparation of a code of obligations and contracts); conducts a course in industrial legislation at French Engineers' School; former member of the Law Academy of Toulouse and of the Board of the Comparative Law Association (Paris); appointed by French Government in 1933 as correspondent of a Committee of Jurists on foreign legislation set up by the Ministry of Justice; lectured at the Academy of International Law at The Hague, 1933, 1937; awarded degree of doctor honoris causa by University of Algiers, 1944; member of Executive Council of the World Federation of International Juridical Institutions (Paris); requested in 1950 by the Middle East Institute, Washington, to prepare a study of conflicts of laws in Islam and their development, a two-volume work; one of the principal contributors to the Revue critique de droit international privé (Paris).

## CARMONA, Ramon

Venezuelan jurist.

Born in Carora, Venezuela, 1902; secondary education at the <u>Colegio Federal</u> of Carora and the <u>Colegio La Salle</u> of Barquisimeto; bachelor's degree, 1919; course of political and social science at the Central University of Venezuela (Caracas); qualified as a lawyer, 1924, and obtained a doctorate of political and social science, 1925.

President of the Constituent Assembly of the State of Lara, 1925; President of the High Court of the State of Lara, 1926; Public Prosecutor of the State of Lara, 1926-1927; entered the Ministry for Foreign Affairs with the rank of official, March 1928; head of the Protocol and Chancellery Division, June 1928; head of the Minister's Staff, December 1928; appointed First Secretary of the delegation to the League of Nations, 1929; also secretary to the Venezuelan representatives in the arbitration between Venezuela and Italy over the Martini-Lanzoni case, 1930.

Specialized studies in international law and political economy at the University of Geneva (Switzerland) and the Institute of International Studies (Paris), 1929-1930; transferred back to the Ministry for Foreign Affairs and held the offices of head of the Commercial Policy Department, head of the Minister's Staff and Counsellor, 1930-1935; appointed head of the Treaty Department, 1936; Venezuelan commercial attaché in Italy, Switzerland, Austria and Yugoslavia, 1937-1942; resumed duty with the Ministry for Foreign Affairs as deputy legal adviser in 1942; appointed adviser in 1946; commercial adviser of the Republic in the United Kingdom, France and Italy, 1947-1949; returned to the Ministry for Foreign Affairs, appointed legal counsellor in 1949, which office he still holds.

Has represented Venezuela in various capacities, from secretary to delegate or head of delegation, in many international conferences and meetings including: League of Nations - First Secretary, 1929-1930; Inter-American Conference for the Consolidation of Peace (Buenos Aires) - First Secretary, 1936-1937; League of Nations Conference on the Co-ordination of Economic Problems (Geneva) -

Born at San Salvador, El Salvador, 1876; Doctor of Law in the Universities of El Salvador and of Guatemala; Minister of El Salvador in France, Italy and Spain, 1912-1930; Minister for Foreign Affairs, Justice and Education; represented El Salvador on the Council of the League of Nations, 1927; President of the tenth Assembly of the League of Nations, 1929,; President of the delegations of El Salvador to the League of Nations Assemblies from 1920 to 1930; President of the Committee on International Public Law at the sixth Pan-American Conference (Havana), 1928; represented El Salvador at many international conferences; member

of the League of Nations Committee on the Codification of International Law; Rapporteur on the question of nationality at the Conference on the Codification of International Law (The Hague), 1930; Vice-President of the Conference for the Control of the International Trade in Arms, Munitions and Implements of War (Geneva), 1925; Vice-President of the International Diplomatic Academy, Paris.

Born in Tokyo, 1886; graduated from the Faculty of Law, Tokyo Imperial University, 1913; entered Ministry for Foreign Affairs, 1914; Chief of Section, Treaties Bureau, Ministry for Foreign Affairs, 1924-1927; counsellor of the Japanese Embassy in France, 1930-1933; Director of Treaties Bureau, Ministry for

Foreign Affairs, 1933-1937; Minister to Sweden, Norway and Denmark, 1937-1939; Ambassador to Belgium and concurrently Minister to Luxembourg, 1939-1940; Justice of the Supreme Court of Japan, 1947 to date; member of the Permanent Court of Arbitration, 1954; Vice-President of Japan Bar Association, 1954.



Member of several learned societies and international commissions.

Since the liberation of Greece, has been appointed a member of several Greek Government Commissions on problems caused by enemy occupation of Greece, for example, the Commission which determined the action to be taken on legislative enactments published in Greece during the occupation, of the Commission dealing with the annulment of judicial acts concluded with the

occupation authorities and enemy subjects, of the Commission on the sequestration of enemy property, of the War Crimes Commission, etc.; member of the Supreme Prize Court and of the Commission for the application of the Peace Treaties.

# VERZIJL, Jan Hendrik Willem

Dutch jurist.

Born at Utrecht, 1888; Doctor of Laws, 1910; Doctor of Political Science, 1917 - thesis on the law of prize as it affected the neutral Powers during the 1914-1920 World War.

After practising administrative law in the service of the municipalities of Leiden and Utrecht, was appointed professor of public international law and diplomatic history at the University of Utrecht in 1919; in 1938, appointed to the University of Amsterdam where he taught public international law and the public law of the Netherlands overseas territories, a post from which he was dismissed in 1941 by the Reichskommissar of the occupying Power; immediately after the liberation of the national territory, appointed Vice-President of the Special Court of Cassation (war criminals), member of the National Pre-Parliamentary Advisory Committee, member of a committee appointed to purge the State legislation of German influence, member of the Board for the restoration of legal rights impaired by the enemy occupation, etc., returned to the University of Utrecht in 1947 as ordinary professor of public international law; also appointed to the University of Leiden as professor of the history of international law and of diplomatic history; President of the French-Mexican Mixed Claims Commission of 1928-1929; counsel for the Free City of Danzig before the Permanent Court of International Justice in the Polish postal service case (1925) and for Bulgaria in its dispute with Greece concerning "communities" (1930); Rector of the University of Utrecht, 1950-1951.

Member of the Permanent Court of Arbitration since 1946; member of the Royal Netherlands Academy of Arts and Science since 1934; President since 1953 of the Franco-Greek Arbitral Tribunal for the settlement of the case concerning the lighthouses of the former Ottoman Empire; member of the Institute of International Law since 1947; has lectured at the Academy of International Law at The Hague, at Belgian universities and at the Faculty of Law at Paris.

Author of several books on public international law and of many articles in Netherlands and foreign journals, <u>inter alia</u>, on the jurisprudence of prize-courts, on a plan of an encyclopedia of public and private international law, on judgments and advisory opinions of the International Court, etc.
