Note by the Secretary-General

- 1. The Secretary-General has the honour to submit to the General Assembly and to the Security Council a supplementary list of chadidates nominated by national groups for the election to be held during the current regular session of the General Assembly in order to elect five judges to succeed Judges Sir Arnold Duncan McNair (United Kingdom), José Gustavo Guerrero (El Salvador), Alejandro Alvarez (Chile), Jules Basdevant (France) and Levi Fernandes Carneiro (Brazil), whose terms of office are due to expire on 5 February 1955.
