GRSP might wish to consider a revised proposal by Germany on the potential misuse of top tether anchorages for ISOFIX child restraint systems, if available.

## 8.2. Mandatory fitting of safety-belt anchorages for Class II buses

GRSP agreed to resume consideration of a revised proposal concerning the mandatory fitting of safety-belt anchorages for Class II buses and the alignment of provisions of the Regulation with those of the corresponding EU Directive 2005/41/EC.

## 9. REGULATION No. 16 (Safety-belts)

## 9.1. Proposal for draft amendments

GRSP may wish to resume consideration of a proposal by CLEPA regarding the alignment of the test of the Regulation with alternative standards, if available.

## 9.2. Mandatory fitting of safety-belts for Class II buses

GRSP agreed to resume consideration of a revised proposal by Italy concerning the mandatory fitting of safety-belt Class II buses and the alignment of provisions of the Regulation with those of the corresponding EU Directive 2005/40/EC.

GRSP may wish to consider a proposal by the Netherlands in order to correct the communication form in Annex 1A which deals with the installation of safety belts.

GRSP agreed to resume consideration of a proposal by OICA aimed at inserting into the Regulation new test methods for the different categories of vehicles.

GRSP agreed to resume consideration regarding the increase of the horizontal plane requirement on the basis of a new document by CLEPA, if available.

#### 12. DRAFT REGULATION ON SEAT COVERS

GRSP agreed to resume consideration of this subject on the basis of a new document by Germany, if available.

GRSP agreed to resume consideration of a proposal by France aimed at extending the use of child restraint systems on categories of vehicles other than  $M_1$  and  $N_1$ .

GRSP experts agreed to express their views on the development of requirements regarding this issue.
