

Security Council Committee established pursuant to resolution 1718 (2006) concerning the Democratic People's Republic of Korea

Note verbale dated 5 February 2007 from the Permanent Mission of Argentina to the United Nations addressed to the Chairman of the Committee

The Permanent Mission of the Argentine Republic to the United Nations presents its compliments to the Chairman of the Security Council Committee established pursuant to resolution 1718 (2006) and has the honour to refer to the note verbale of 22 November 2006.

Also enclosed herewith is a copy of resolution 52/2007 of the Ministry of Foreign Affairs, International Trade and Worship, which promulgates the regime of sanctions imposed on the Democratic People's Republic of Korea (see annex).

Annex to the note verbale dated 5 February 2007 from the Permanent Mission of Argentina to the United Nations addressed to the Chairman of the Committee

Considering the provisions of Decree No. 1521 of 1 November 2004 and the decisions taken by the United Nations Security Council in resolution 1718 (2006) concerning the sanctions regime imposed on the Democratic People's Republic of Korea, and

Whereas:

Decree No. 1521/2004 stipulates that Security Council resolutions adopted under Chapter VII of the Charter of the United Nations which establish measures binding on Member States that do not involve the use of armed force but entail sanctions, as well as decisions regarding the amendment or termination thereof, shall be promulgated by the Ministry of Foreign Affairs, International Trade and Worship by means of resolutions published in the Official Gazette;

By its resolution 1718 (2006) the Security Council established a regime of sanctions against the Democratic People's Republic of Korea;

It is necessary to promulgate the said sanctions regime;

At the proposal of the Directorate for International Organizations, the appropriate action has been taken by this Ministry's Office of the Secretary for Foreign Affairs, Office of the Under-Secretary for Foreign Policy, Directorate-General for Legal Affairs, Directorate for Asia and Oceania, Directorate for International Security and Nuclear and Space Affairs and Directorate-General for Consular Matters;

Now, therefore,

The Minister for Foreign Affairs, International Trade and Worship

Resolves

Article 1 — In conformity with Decree No. 1521 of 1 November 2004, the measures adopted by the United Nations Security Council in its resolution 1718 (2006) concerning the sanctions regime applicable to the Democratic People's Republic of Korea, which, as annex 1, shall form an integral part of the present resolution, are hereby promulgated.

Article 2 — The Ministry of Foreign Affairs, International Trade and Worship shall promulgate, by means of resolutions published in the Official Gazette, the lists of individuals and entities designated by the United Nations Security Council Committee established by paragraph 12 of resolution 1718 (2006).

Article 3 — This resolution shall be notified, published and transmitted to the National Official Registry and placed in the archives.
