Calendar of conferences and meetings of the United Nations for 2007

Note by the Secretariat

1. The Secretariat is circulating herewith, as an annex to the present note, the calendar of conferences and meetings of the United Nations for 2007 as adopted by the General Assembly in its resolution 61/236, taking into account other resolutions and decisions adopted by the Assembly at its sixty-first session.

2. The calendar of conferences and meetings of the principal organs of the specialized agencies, the International Atomic Energy Agency and treaty bodies established under the auspices of the United Nations for 2007 is also contained in the annex.

3. By its decision 1/102, the Human Rights Council decided to extend exceptionally for one year, subject to the review to be undertaken by the Council in conformity with General Assembly resolution 60/251, the mandates and the mandate holders of all the special procedures of the Commission on Human Rights, of the Sub-Commission on the Promotion and Protection of Human Rights, as well as the procedure established in accordance with Economic and Social Council resolution 1503 (XLVIII), with the exception of the following two subsidiary bodies of the Council whose mandates were extended separately:

- Open-ended working group to elaborate an optional protocol to the International Covenant on Economic, Social and Cultural Rights (extended by resolution 1/3 of the Council for a period of two years);
- Intergovernmental working group on effective implementation of the Durban Declaration and Programme of Action (extended by resolution 1/5 of the Council for a period of three years).
