On instructions from my Government, I have the honour to transmit to you herewith a summary of violations of the Blue Line, covering roughly the last two months, from 29 January 2007 to 20 March 2007 (see annex).

Though the summary contains only data from the recent period, it is important to note that the number of violations is in addition to the previous 155 violations recorded since the beginning of the ceasefire, on 14 August 2006, until the start of the aforementioned period.

Israel remains concerned about the developing situation along the Blue Line, reconfirmed by incidents of the last month, including the Lebanese Army's confiscation of arms on their way to Hizbullah and the Israel Defense Forces' discovery of explosive devices in a salient south of the Blue Line. The rearming of Hizbullah is a significant and pressing danger. As such, all efforts should be made to ensure the full implementation of Security Council resolution 1701 (2006).

Specifically, Israel's concerns centre on the presence of armed Hizbullah elements south of the Litani River and the violation of the embargo and transfer of weapons from the Syrian Arab Republic to Hizbullah in Lebanon. Israel is also concerned that some of those weapons are destined for south Lebanon, as Hizbullah leader Hassan Nasrallah has already admitted moving arms to the "front". Additionally, the two Israeli soldiers kidnapped by Hizbullah on 12 July 2006, Udi Goldwasser and Eldad Regev, have yet to be released, as called for by the Security Council in its resolution 1701 (2006), nor has any sign of life been shown.



I should be grateful if you would have the present letter and its annex circulated as a document of the General Assembly, under agenda item 13, and of the Security Council.

Three (3) additional Lebanese civilians crossed the blue line and joined the other three (3). The six (6) Lebanese civilians videotaped and photographed Israeli territory
