## Report of the Arab Republic of Egypt pursuant to Security Council resolution 1737 (2006)

In connection with Security Council resolution 1737 of 23 December 2006 and in implementation of operative paragraph 19 thereof concerning the presentation by States of a report on steps taken to implement paragraphs 3, 4, 5, 6, 7, 8, 10, 12 and 17, the steps taken by Egypt are set out below.

1. With regard to paragraphs 3, 4 and 5 concerning prevention of the supply of a number of items, materials, equipment, goods and technology:

Egypt does not supply to the Islamic Republic of Iran any of the items, materials, equipment, goods and technology indicated in document INFCIRC/254/Rev.8/Part 1;

Egypt does not supply to Iran any of the items, materials, equipment, goods and technology indicated in document INFCIRC/254/Rev.8/Part 2;

With regard to document S/2006/815 concerning the list of items, materials, equipment, goods and technology relevant to the ballistic missile programme, there is no former or pending military cooperation between Egypt and Iran.

- 2. With regard to paragraph 6, Egypt does not supply Iran with any type of technical assistance or training, financial assistance, investment, brokering or other services or transfer of financial resources or services, related to the supply, sale, transfer, manufacture or use of the prohibited items, materials equipment, goods and technology specified in paragraphs 3 and 4 of Security Council resolution 1737 (2006).
- 3. With regard to paragraph 7, neither Iran nor any of its nationals export any of the items mentioned in documents S/2006/814 and S/2006/815 to Egypt, nor do they use Iranian flag vessels or aircraft to do so.
- 4. With regard to paragraph 10, the Egyptian authorities have taken note of the list of persons identified by the Security Council Committee established pursuant to resolution 1737 (2006) and taken the required national measures.
- 5. With regard to paragraph 12, the list of persons and entities identified by the Committee has been circulated to the banks registered with the Central Bank of Egypt in order to freeze all funds, accounts and assets of the persons and entities listed, and any information or transactions in this regard continued to be monitored.
- 6. With regard to paragraph 17, there is no cooperation between Egyptian universities or educational institutions with any Iranian scientific or educational institution in any specializations that would contribute to Iran's sensitive nuclear proliferation activities or the development of nuclear weapon delivery systems.
