## Item 2 Annual report of the Administrator

The multi-year funding framework (MYFF) 2004-2007 (document DP/2003/32) was approved by the Executive Board at the second regular session 2003. It established goals and intended organizational results for the four-year period. The goals derived principally from the demand for UNDP assistance from programme countries, and embodied a range of corporate and international objectives and concerns, such as the Millennium Development Goals (MDGs) and other internationally agreed development targets, United Nations reform priorities, and the specific mandates assigned to UNDP by the General Assembly.

The current report presents a comprehensive view of results and progress achieved over the first three years of the MYFF period. Its observations are based on the performance analysis of 135 country programmes, reporting on the UNDP contribution to development effectiveness. Consistent with Executive Board requirements, the report contains performance information on programme focus and results, organizational strategies, and expenditures to achieve the objectives of the MYFF.

The Board may wish to adopt a decision, elements of which are contained in the report.

Pursuant to General Assembly resolution 59/267, para 27, the Executive Board will also have before it the report of the Joint Inspection Unit (JIU). This report provides a synopsis of management comments on the relevant recommendations contained in the 6 reports issued by the Joint Inspection Unit (JIU) in 2006. In line with the desire of the Executive Board and the current United Nations emphasis on

simplification and harmonization, the present report has been prepared jointly by UNDP and UNFPA

The statistical annex contains detailed financial information on the annual stock of income and expenditures for field programme activities of UNDP and the funds and trust funds administered by UNDP.

## Item 4 UNDP strategic plan, 2008-2011

The draft strategic plan is being submitted in line with Executive Board decisions 2006/1 and 2007/2, which requested the UNDP Administrator to submit a draft version of the multi-year funding framework (MYFF), 2008-2011, to the Board at its annual session in 2007. The strategic plan, which replaces the MYFF, sets the overall direction for UNDP support to programme countries to achieve their nationally-owned human development outcomes over the next four years. The plan highlights the urgent need for additional efforts by the international community to make the achievement of the Millennium Development Goals a reality by 2015, and adopts 'inclusive growth' as its connecting theme, to place particular attention on those that are being left farthest behind. It articulates the dual coordinating and programmatic role of UNDP and emphasizes the overarching focus of the organisation on national ownership and national capacity-strengthening. The plan also articulates UNDP operational principles that will be integrated in all areas of

operations and programming for 2008-2011. Lessons learned from the previous MYFF have been built into the strategic plan, which also seeks to introduce more clearly defined performance indicators and targets to facilitate greater accountability for results. Finally, the plan includes an integrated financial resources framework which covers both core and non-core resources.

The Executive Board may wish to take note of the draft strategic plan and provide comments to guide its finalization for submission at the second regular session 2007.

In response to decision 2007/4 and in the framework of discussion with the Board on the UNDP strategic plan, 2008-2011, the Board will also have before it the UNDP strategic vision on assistance to crisis-affected countries. The Board may wish to take note of the report.

### Item 5 Evaluation

It also describes progress made in advancing the United Nations reform agenda in evaluation and strengthening national ownership of evaluation. Drawing from independent evaluations and evaluations undertaken by the associated funds and programmes, the report presents an analysis of key emerging issues, findings, and recommendations and presents a number of organizational lessons. The report also presents the programme of work for the Evaluation Office. The Executive Board may wish to adopt a decision, elements of which are contained in the report.

At the annual session 2004, the Associate Administrator committed UNDP to undertaking forward-looking evaluations prior to the drafting and submission of new regional programmes. The evaluations of the second regional cooperation frameworks for Africa (2002-2006), Asia and the Pacific (2002-2006) and Latin America and the Caribbean (2001-2005) are presented. The reports provide findings of the independent evaluations conducted in 2006 in terms of the relevance, effectiveness, efficiency and sustainability of the respective RCFs. Lessons learned are presented, as well as recommendations for consideration by the respective

regional bureaux in formulation of the regional programmes. The Board may wish to adopt a decision on the findings of the evaluations.
