### **Security Council Committee established pursuant to resolution 1737 (2006)**

#### **Note verbale dated 21 June 2007 from the Permanent Mission of the Republic of Korea to the United Nations addressed to the Chairman of the Committee**

The Permanent Mission of the Republic of Korea to the United Nations presents its compliments to the Chairman of the Security Council Committee established pursuant to Security Council resolution 1737 (2006), and has the honour to submit herewith the report of the Republic of Korea, pursuant to paragraph 8 of Security Council resolution 1747 (2007), on the steps taken by the Government of the Republic of Korea with a view to implementing the relevant provisions of the latter resolution (see annex).

**Report of the Republic of Korea on the implementation of measures set out in Security Council resolution 1747 (2007)**

- Operative paragraph 8 of Security Council resolution 1747 (2007) calls upon all Member States to report to the Security Council on the steps taken with a view to implementing said resolution. The Republic of Korea (ROK) wishes to inform the Security Council that it is effectively implementing all measures contained in Security Council resolution 1747.
- All relevant authorities of the Republic of Korea have been fully informed of the decision made by the Security Council on the Islamic Republic of Iran, and have taken the necessary measures for the effective implementation of Security Council resolution 1747.
- As a member of all international non-proliferation and export control regimes relating to nuclear, chemical and biological weapons, missiles and conventional weapons, such as the Nuclear Suppliers Group (NSG), the Missile Technology Control Regime (MTCR), the Australia Group (AG), the Zangger Committee (ZC) and the Wassenaar Arrangement (WA), the Republic of Korea has been implementing strict export and import controls over nuclear, chemical and biological weapons, missiles and conventional weapons in conformity with international standards.
- Major laws and regulations on export controls in the Republic of Korea include the *Foreign Trade Act*, the *Technology Development Promotion Act*, the *Atomic Energy Act*, and the *Defense Industry Act*, and their related regulations. The *Combined Notice of Export/Import of Strategic Items and Technologies* covers all controlled items from the five multilateral export control regimes (NSG, MTCR, AG, ZC and WA), and provides for detailed export and import control regulations, and the specification of controlled items.
- In addition, the individuals and entities designated by Security Council resolution 1747 have been added to the *Database List of Persons and Entities Not Suitable for Export of Strategic Items*.
- The measures called for in Security Council resolution 1747 have been reflected in the immigration system to monitor the entry into or transit through the territory of the Republic of Korea of the persons designated in the resolution.
- The ROK Government has revised the *Public Notice for International Peace and Security* for the freezing of funds, other financial assets and economic resources that are owned or controlled by the persons or entities designated by the Security Council. Moreover, the ROK Government has taken measures to ensure that no grants, financial assistance, and concessional loans, except for humanitarian and developmental purposes, are provided to the Government of the Islamic Republic of Iran.
