REPORT BY THE SECRETARY-GENERAL CONCERNING THE CREDENTIALS OF THE REPRESENTATIVES AND DEPUTY AND ALTERNATE REPRESENTATIVES OF THE MEMBERS OF THE SECURITY COUNCIL ELECTED FOR THE PERIOD 1984-1985

At its 40th meeting, on 31 October 1983, the General Assembly elected Egypt, India, Peru, the Ukrainian Soviet Socialist Republic and the Upper Volta non-permanent members of the Security Council for a term of two years, beginning on 1 January 1984.

Pursuant to rule 15 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to report that, with regard to the representation of the members of the Security Council elected for the period 1984-1985, he has received the communications referred to hereunder.

Egypt. In a letter dated 15 December 1983, the Deputy Prime Minister and Minister for Foreign Affairs of the Arab Republic of Egypt stated that Mr. Ahmed Tawfik Khalil has been appointed representative of Egypt on the Security Council.

In the opinion of the Secretary-General, these credentials are in order.

India. In a letter dated 30 November 1983, the Minister of External Affairs of India stated that Mr. Natarajan Krishnan has been appointed representative of India on the Security Council, that Mr. Vinay Verma has been appointed deputy representative and that Miss Savitri Kunadi and Mr. Amitav Banerji have been appointed alternate representatives.

In the opinion of the Secretary-General, these credentials are in order.

<u>Peru.</u> Credentials signed on 13 December 1983 by the Prime Minister and Minister for External Relations of Peru state that Mr. Javier Arias Stella has been appointed representative of Peru on the Security Council and that Mr. Ricardo Luna Mendoza has been appointed alternate representative.

In the opinion of the Secretary-General, these credentials are in order.

Ukrainian SSR. In a letter dated 2 December 1983, the Minister for Foreign Affairs of the Ukrainian Soviet Socialist Republic stated that Mr. Vladimir

Alekseyevich Kravets has been appointed representative of the Ukrainian Soviet Socialist Republic on the Security Council and that Mr. Boris Ivanovich Korneenko and Mr. Vladimir Fedorovich Skofenko have been appointed deputy representatives on the Security Council.

In the opinion of the Secretary-General, these credentials are in order.

Upper Volta. In a letter dated 29 December 1983, the Permanent Representative of the Upper Volta to the United Nations stated that Mr. Léandre Bassole has been appointed representative of the Upper Volta on the Security Council, that Mr. Doulaye Corentin Ki and Mr. R. Gaëtan Ouedraogo have been appointed deputy representatives and that Mr. Bruno Zidouemba, Mr. Honoré Kompaore and Mr. Antonin Ouedraogo have been appointed alternate representatives.

In the opinion of the Secretary-General, this communication constitutes adequate provisional credentials.
