Subject: **Post adjustment classification for New York**

1. The International Civil Service Commission has determined that the requirement for the application of post adjustment multiplier 65 for staff in the Professional and higher categories serving in New York has been met as at 1 September 2007. Consequently, effective 1 September 2007, the post adjustment multiplier for New York is being revised from 59.9 to 65.
2. The annual amounts of post adjustment at multiplier 65 for each salary level and step are shown in the annex to the present circular.
3. The implementation of the revised post adjustment multiplier will be reflected in the end-of-September 2007 payroll.

* The present circular, which cancels and supersedes ST/IC/2007/4 of 12 January 2007, will be in effect until further notice.
