LETTER DATED 28 FEBRUARY 1964 FROM THE ACTING PERMANENT
REPRESENTATIVE OF TURKEY ADDRESSED TO THE PRESIDENT OF
THE SECURITY COUNCIL

MAKARIOS' ANNOUNCEMENT THAT HE HAS DECIDED TO INCREASE GREEK MEMBERS OF SECURITY FORCES TO 5,000 IS A FLAGRANT VIOLATION OF BASIC ARTICLE 130 OF CONSTITUTION WHICH EXPRESSLY PROVIDES THAT STRENGTH OF SECURITY FORCES MAY ONLY BE INCREASED BY COMMON AGREEMENT OF THE PRESIDENT AND THE VICE-PRESIDENT OF THE REPUBLIC. MY AGREEMENT HAS NEVER BEEN SOUGHT NOR OBTAINED.

IT IS A COMMON KNOWLEDGE THAT PLANNED MASSACRE OF TURKS IN CYPRUS WAS EXECUTED BY THOUSANDS OF ILLEGALLY ARMED GREEKS PRETENDING TO BE LEGAL FORCES OF THE REPUBLIC. BY HIS ARBITRARY DECISION TO INCREASE THE STRENGTH OF SO-CALLED SECURITY FORCES MAKARIOS IS ATTEMPTING TO GIVE A CLOAK OF LEGALITY TO GREEK TERRORIST HORDES WHICH IN FACT NUMBERED MORE THAN 40,000 ACCORDING ADMISSION OF GREEK MINISTER. AT A TIME WHEN CYPRIOTE GREEK DELEGATION IS USING DELAYING TACTICS AT THE SECURITY COUNCIL AND SINCE LONDON CONFERENCE AND THUS PREVENTING SPEEDY DISPATCH TO CYPRUS OF AN EFFECTIVE PEACE-KEEPING FORCE, THIS ADVICE OF MAKARIOS IS DESIGNED TO PREPARE WAY FOR ANOTHER GREEK GENOCIDE ATTEMPT AGAINST TURKS AND AGGRAVATE ALREADY TENSE SITUATION IN CYPRUS.

MOREOVER BEFORE A FINAL SETTLEMENT IS REACHED AND BEFORE PEACE AND ORDER IS FULLY SECURED IN THE ISLAND, MAKARIOS' ATTEMPT TO CONFISCATE ARMS WHICH ATTEMPT BEING NO DOUBT REALLY AIMED AT TURKS IS A BREACH OF THE CEASE-FIRE AGREEMENT REACHED BETWEEN THE TWO PARTIES. REQUEST COPIES OF THIS CABLE BE DISTRIBUTED TO ALL MEMBERS OF THE SECURITY COUNCIL.
