The session will be chaired by the country leading the UNECE Steering Committee on ESD.
- 8. The session will open with a welcoming address by the Minister of Education of Serbia (up to 5 minutes) followed by introductory remarks by the Chairperson (up to 5 minutes). Keynote addresses will be given by education and environment ministers and by a representative of the United Nations Educational, Scientific and Cultural Organization (UNESCO) (up to 5 minutes per keynote address). Thereafter, the key findings of the report on progress in implementation of the UNECE Strategy for ESD will be presented (up to 10 minutes).
- 9. Delegates will be invited to engage in an interactive discussion (up to 3 minutes per intervention). They will be expected to discuss the main concerns relating to the implementation of ESD in phases II and III, with a focus on achievements, challenges and future steps for reaching the six objectives of the UNECE Strategy.

A second roundtable discussion on "Society in nature, nature in society" will open with a keynote address by the Executive Director of the United Nations Environment Programme (UNEP) (up to 5 minutes), followed by the discussion (up to 3 minutes per intervention).
- 14. Thereafter, the floor will be opened for interactive discussion from the floor (up to 3 minutes per intervention).

- 16. The session on biodiversity will be closed by the launching of a multi-stakeholder initiative introduced by a keynote address by a minister (up to 5 minutes).
