**Statistical summary of Israeli violations, acts of aggression and other activities between 24 and 30 September 2007**

*Air violations*

On 24 September, between 1504 and 1610 hours, two enemy Israeli warplanes violated Lebanese airspace over Kafr Killa flying north as far as Shikka, circled between the South, Shikka and the Bekaa and then departed over Rumaysh.

Between 1944 and 2000 hours, two enemy Israeli warplanes violated Lebanese airspace over Naqurah flying north as far as Jubayl, then departed over Rumaysh.

Between 2008 and 2130 hours, two enemy Israeli warplanes violated Lebanese airspace over Naqurah flying north and circled between Beirut, the South, the Bekaa and Shikka, then departed over Rumaysh.

Between 2114 and 2345 hours, an enemy Israeli reconnaissance aircraft violated Lebanese airspace over the sea off Tyre, circled off Sidon and Tyre then departed over the sea off Naqurah.

On 25 September 2007, between 0940 and 1210 hours, an enemy Israeli reconnaissance aircraft violated Lebanese airspace over 'Alma al-Sha'b and circled over areas of Riyaq, Baalbek and the South, then departed over Rumaysh.

Between 1345 and 1450 hours, two enemy Israeli warplanes violated Lebanese airspace over Kafr Killa and circled over areas of Shikka, the Bekaa, Beirut and the South, then departed over Rumaysh.

Between 1915 and 2145 hours, an enemy Israeli reconnaissance aircraft violated Lebanese airspace over the sea off Tyre and circled over the South, then departed over Rumaysh.

On 26 September 2007, between 0115 and 0300 hours, two enemy Israeli warplanes violated Lebanese airspace over 'Alma al-Sha'b and circled over areas of Shikka, Beirut and the South, then departed over the sea off Naqurah.

Between 1100 and 1210 hours, four (4) enemy Israeli warplanes violated Lebanese airspace over Rumaysh flying north and circled over areas of the South, then departed over 'Alma al-Sha'b.

Between 1105 and 1240 hours, two enemy Israeli warplanes violated Lebanese airspace over Kafr Killa and circled over areas of Shikka and al-Arz, then departed over Naqurah.

On 27 September 2007, between 0950 and 1020 hours, an enemy Israeli reconnaissance aircraft violated Lebanese airspace over Kafr Killa flying north as far as Jabb Janin and circled over areas of Jubb Janin, Rashayya and Hasbayya, then departed over Rumaysh.

Between 1155 and 1325 hours, two enemy Israeli warplanes violated Lebanese airspace over Kafr Killa flying north and circled between Shikka and the South, then departed over 'Alma al-Sha'b.

On 28 September 2007, between 0135 and 0145 hours, two enemy Israeli warplanes violated Lebanese airspace over the sea off Juniyah flying east as far as the coast of Juniyah, then headed south and departed over 'Alma al-Sha'b.

Between 0150 and 0310 hours, two enemy Israeli warplanes violated Lebanese airspace over Naqurah flying north and circled between Beirut and the South, then departed over Rumaysh.

Between 0934 and 1045 hours, two enemy Israeli warplanes violated Lebanese airspace over Kafr Killa and circled over Shikka, al-Arz, Beirut and the South, then departed over Rumaysh.

On 29 September 2007, between 1126 and 1300 hours, two enemy Israeli warplanes violated Lebanese airspace over Dayr Mimas and circled over areas of Tripoli, the Bekaa, Beirut and the South, then departed over 'Alma al-Sha'b.

On 30 September 2007, between 1135 and 1300 hours, two enemy Israeli warplanes violated Lebanese airspace over Dayr Mimas flying north as far as Tripoli and circled over areas of the South, the Bekaa, Tripoli and Beirut, then departed over 'Alma al-Sha'b.

Between 2005 and 2105 hours, an enemy Israeli reconnaissance aircraft violated Lebanese airspace over the sea off Naqura and flying as far as Beirut, circled over Beirut and Tyre and then departed over the sea off Naqurah.

*Sea violations*

None.

*Field hostilities*

On 25 September 2007, between 1900 and 1945 hours, the Israeli enemy fired a number of rounds of light- and medium-weapons fire from the Radar outpost (at Shab'a) into the area around the outpost.

On 26 September 2007, at 2205 hours, the Israeli enemy shone a searchlight from Zarit barracks on the Mirwahin triangle.

On 29 September 2007, at 2200 hours, the Israeli enemy shone a searchlight from Zarit barracks in the direction of the Mirwahin-Ramyah-Jabal Blat triangle.
