## Agenda item 113

## Elections to fill vacancies in subsidiary organs and other elections

## (a) Election of seven members of the Committee for Programme and Coordination

Note by the Secretary-General (A/62/77)
The President: Pursuant to General Assembly decision 42/450 of 17 December 1987 and upon nomination by the Economic and Social Council, the Assembly elects the members of the Committee for Programme and Coordination.

The Assembly has before it document A/62/77, which contains the nominations by the Economic and Social Council to fill the vacancies in the Committee that will occur as a result of the expiration, on 31 December 2007, of the terms of office of Algeria, China, Ghana, Jamaica, Japan, Kenya and the Republic of Korea. Those States are eligible for immediate re-election.

I should like to remind members that, after 1 January 2008, the following States will still be members of the Committee: Argentina, Armenia, Belarus, Benin, Brazil, Bulgaria, the Central African Republic, the Comoros, Cuba, France, Haiti, India, Indonesia, the Islamic Republic of Iran, Israel, Italy, Pakistan, Portugal, the Russian Federation, Senegal, South Africa, Switzerland, Uruguay, the Bolivarian
(The former Yugoslav Republic of Macedonia)
Republic of Venezuela and Zimbabwe. Therefore, those 25 States are not eligible in this election.

I should now like to inform members that the following States have been nominated by the Economic and Social Council: the three African States for three vacancies are Kenya, the Libyan Arab Jamahiriya and Niger; the three Asian States for three vacancies are Bangladesh, China and the Republic of Korea; and the one Latin American and Caribbean State for one vacancy is Jamaica.

In accordance with rule 92 of the rules of procedure, all elections should be held by secret ballot and there shall be no nominations. However, I should like to recall paragraph 16 of General Assembly decision 34/401, whereby the practice of dispensing with the secret ballot for elections to subsidiary organs when the number of candidates corresponds to the number of seats to be filled should become standard, unless a delegation specifically requests a vote on a given election.

In the absence of such a request, may I take it that the Assembly decides to proceed to the election on the basis of dispensing with the secret ballot?

## It was so decided.

The President: The number of States nominated from among the African States, the Asian States and the Latin American and Caribbean States is equal to the number of seats to be filled in each of those groups.

May I therefore take it that the Assembly wishes to declare those States nominated by the Economic and

[^0]Social Council from among the African States, the Asian States and the Latin American and Caribbean States, namely, Bangladesh, China, Jamaica, Kenya, the Libyan Arab Jamahiriya, the Niger and the Republic of Korea, elected members of the Committee for Programme and Coordination for a three-year term of office beginning on 1 January 2008?

## It was so decided.

The President: I congratulate the States that have just been elected members of the Committee for Programme and Coordination.

Members will recall that from previous sessions, and as indicated in document $A / 62 / 77$, there remain two vacancies in the Group of Western European and other States for members whose term of office would begin on the date of election. One term will expire on 31 December 2008 and the other on 31 December 2009. The General Assembly will be in a position to act on those vacancies upon the nomination by the Economic and Social Council of two Member States from that region.

We have thus concluded this stage of our consideration of sub-item (a) of agenda item 113.

## (b) Election of twenty-nine members of the Governing Council of the United Nations Environment Programme

The Acting President: Pursuant to General Assembly resolution 2997 (XXVII) of 15 December 1972 and Assembly decision 43/406 of 24 October 1988, the Assembly will proceed to the election of 29 members of the Governing Council of the United Nations Environment Programme, to replace those members whose term of office expires on 31 December 2007.

The 29 outgoing members are the Bahamas, Bangladesh, Brazil, Bulgaria, Burkina Faso, Cameroon, Cape Verde, Colombia, Costa Rica, Ghana, Hungary, India, the Islamic Republic of Iran, Israel, Kazakhstan, Kyrgyzstan, Mexico, Monaco, Morocco, Netherlands, Poland, Saudi Arabia, Senegal, Somalia, Sweden, Turkey, Tuvalu, the United Kingdom of Great Britain and Northern Ireland and the United Republic of Tanzania. Those States are also eligible for immediate re-election.

I should like to remind members that, after 1 January 2008 the following States will still be members of the Governing Council: Algeria, Angola, Antigua and Barbuda, Argentina, Australia, Austria, Belgium, Botswana, Burundi, Canada, Chile, China, the Czech Republic, the Democratic Republic of the Congo, France, Germany, Haiti, Indonesia, Japan, Kenya, Pakistan, the Republic of Korea, Romania, the Russian Federation, South Africa, Thailand, Uganda, the United States of America and Uruguay. Therefore, those 29 States are not eligible in this election.

As members know, in accordance with rule 92 of the rules of procedure, all elections shall be held by secret ballot and there shall be no nominations. However, I should like to recall paragraph 16 of General Assembly decision 34/401, whereby the practice of dispensing with the secret ballot for elections to subsidiary organs when the number of candidates corresponds to the number of seats to be filled should become standard, unless a delegation specifically requests a vote on a given election.

In the absence of such a request, may I take it that the Assembly decides to proceed to the election on that basis?

## It was so decided.

The Acting President: Regarding candidatures, I have been informed by the Chairmen of the regional groups that for the eight seats from the African States, the eight endorsed candidates are Benin, the Congo, Guinea, Mali, Mauritius, the Niger, Somalia and Tunisia.

For the seven seats from the Asian States, the seven endorsed candidates are Bangladesh, Fiji, India, the Islamic Republic of Iran, Kazakhstan, Saudi Arabia and Tuvalu.

For the three seats from the Eastern European States, the three endorsed candidates are Belarus, Croatia and Hungary.

For the five seats from the Latin American and Caribbean States, the five endorsed candidates are the Bahamas, Colombia, Costa Rica, Cuba and Mexico.

For the six seats from the Western European and other States, the six endorsed candidates are Finland, Israel, Italy, Monaco, the Netherlands and Spain.

Since the number of candidates endorsed by the African States, the Asian States, the Eastern European

States, the Latin American and Caribbean States and the Western European and other States corresponds to the number of seats to be filled in each region, may I take it that the General Assembly decides to elect those candidates as members of the Governing Council of the United Nations Environment Programme for a fouryear term of office beginning on 1 January 2008?

## It was so decided.

The Acting President: The following 29 States have thus been elected members of the Governing Council of the United Nations Environment Programme for a four-year term of office beginning on 1 January 2008: the Bahamas, Bangladesh, Belarus, Benin, Colombia, the Congo, Costa Rica, Croatia, Cuba, Fiji, Finland, Guinea, Hungary, India, the Islamic Republic of Iran, Israel, Italy, Kazakhstan, Mali, Mauritius, Mexico, Monaco, the Netherlands, the Niger, Saudi Arabia, Somalia, Spain, Tunisia and Tuvalu.

I congratulate the States that have been elected members of the Governing Council of the United Nations Environment Programme.

May I take it that it is the wish if the General Assembly to conclude its consideration of sub-item (b) of agenda item 113?

## Note by the Secretary-General (A/62/107)

The Acting President: As indicated in document A/62/107, since the terms of office of Austria, China, Egypt, Jamaica, Kenya, Nepal and the United States of America will expire on 31 December 2007, it will be necessary for the President of the General Assembly to appoint, during the current session, seven members in order to fill the resulting vacancies. Those members will serve for a period of three years, beginning on 1 January 2008.

After consultations with the Chairmen of the groups of African States, Asian States and Western European and other States, the President has appointed

Austria, China, Japan, Kenya, Tunisia and the United States of America as members of the Committee on Conferences for a period of three years, beginning on 1 January 2008.

May I take it that the Assembly takes note of those appointments?

It was so decided.
The Acting President: Regarding the remaining vacant seat from among the Latin American and Caribbean States, the President will continue to hold consultations with that regional group.
