Introduction

1. With the expected application of a new Directive of the Council of the European Union and the European Parliament on the inland transport of dangerous goods as from 1 January 2009, the Regulations annexed to the ADN will be applied in all Member States of the European Union. According to this directive, it will be possible also for Member States of the European Union which are not Contracting Parties to ADN to issue certificates of approval and provisional certificates of approval according to section 1.16.2. In order to prevent differing views on their scope, a clarifying regulation should be agreed.

Proposal

- 2. In section 1.16.2, add the following new sub-section 1.16.2.5:
 - "1.16.2.5 Certificates of approval and provisional certificates of approval issued according to Directive 2007/xx/EC on the inland transport of dangerous goods shall be considered as equivalent.

Justification

3. The purpose of this proposal is to prevent problems concerning the application. There will be no negative effects on safety and feasibility.
