Future organization and methods of work of the Commission for Social Development

Note by the Secretariat

Summary

The present note is prepared pursuant to Economic and Social Council resolution 2005/11, by which the Commission for Social Development was called upon to undertake a review of the functioning of the two-year review and policy cycle in order to ensure that that approach enhanced its effectiveness and functioning. Furthermore, pursuant to Council resolution 2006/18, the Commission is expected to identify the theme for the 2009-2010 review and policy cycle. The note presents some background on the review of the methods of work of the Commission, and a proposal for the 2009-2010 priority theme.

I. Background

- 1. The General Assembly, in its resolution 57/270 B, requested each functional commission to examine its methods of work in order to better pursue the implementation of the outcomes of the major United Nations conferences and summits.
- 2. In February 2005, at its forty-third session, the Commission for Social Development commemorated the tenth anniversary of the World Summit for Social Development, at which time its primary role in follow-up to the Summit based on the three core goals or elements of poverty eradication, employment and social integration, was reaffirmed.
- 3. At its forty-second, forty-third and forty-fourth sessions, the Commission for Social Development considered the reports of the Secretary-General (E/CN.5/2004/2 and E/CN.5/2005/2, respectively) and a note by the Secretariat on its methods of work (E/CN.5/2006/5).
- 4. In its resolutions 2005/11 and 2006/18 on the future organization and methods of work of the Commission, the Economic and Social Council decided that the work of the Commission would be organized in a series of two-year, action-oriented implementation cycles that would include a review segment, and a policy segment, and that the theme for the 2007-2008 review and policy cycle would be "Promoting full employment and decent work for all".
- 5. Focusing on one core issue over a two-year period, it is believed, would enable the Commission to go into greater depth by also addressing related cross-cutting issues, emerging issues and linkages with other issues relevant to the theme under discussion.
- 6. The Council also decided that the Commission for Social Development should include in its work a consideration of the nature of its outcomes and the inclusion of emerging issues within its programme of work.

II. Theme for the 2009-2010 review and policy cycle

- 7. In its resolution 2006/18, the Economic and Social Council noted the usefulness of identifying the theme for the 2009-2010 review and policy cycle during the forty-sixth session of the Commission.
- 8. In view of the fact that the Commission took up the issue of poverty eradication at its forty-fourth session and full employment and decent work at its forty-fifth and forty-sixth sessions, the Secretariat, in consultation with the Bureau of the Commission, proposes the theme "Social integration" as the priority theme for the 2009-2010 review and policy cycle.

III. Review of the Commission's review and policy cycle

9. During its forty-sixth session, in 2008, pursuant to Economic and Social Council resolution 2005/11, the Commission will undertake a review of the functioning of the two-year review and policy cycle to ensure that that approach enhances its effectiveness and functioning.
