LAWS AND REGULATIONS

PROMULGATED TO GIVE EFFECT TO THE PROVISIONS OF THE INTERNATIONAL TREATIES ON NARCOTIC DRUGS AND PSYCHOTROPIC SUBSTANCES

Order No. 57 of the Ministry of the Interior of 13 February 1986

ORDER TO AMEND ORDER ON EUPHORIANT SUBSTANCES

- 1.-(1) Order No. 559 of 9th November 1984 on Euphoriant Substances shall be amended as follows:
- 1. First clause of subsection 1 of section 4: The word "plants" shall be inserted after "substances".
- 2. Second clause of subsection 1 of section 1: The word "plants" shall be inserted after "drugs".
- *) Note by the Secretariat: The present document is a direct reproduction of the text communicated to the Secretariat.

- 3. New subsection 3 of section 2:
- "(3) The plant indicated in list A as No. 6 can irrespective of the provisions of subsections 1 and 2 be grown for trade purposes in order to produce seeds without authorization from the National Board of Health."
- 4. Subsection 1 of section 8 and subsection 1 of section 9: The following shall be deleted:

"and all parts of the plant Papaver somniferum L - with the exception of the seeds -"

- 5. Subsection 1 of section 8 and subsection 1 of section 9: the word "other" in front of "plants or parts of plants" shall be deleted.
- 6. New No. 6 of list A of appendix 1 of the Order to be inserted:
- "6. The plant Papaver somniferum L (shich means all parts of plants belonging to the genus Papaver somniferum L with the exception of the seeds)."
- 7. New No. 85a on list B of appendix 1 of the Order to be inserted after No. 85:
 - "35a. 2.5-dimethoxy-4-bromamphetamin."
- 8. New 74 a on list B of appendix 1 of the Order to be inserted after No. 74:
 - "74 a. 3.4-methylendioxyamphetamin".
- 9. List of examples 1 of appendix 1 of the Order: The following shall be deleted:
