### Credentials of representatives to the sixty-second session of the General Assembly

#### Report of the Credentials Committee

*Chairman:* Mr. Vanu Gopala **Menon** (Singapore)

1. At its 1st plenary meeting, on 18 September 2007, the General Assembly, in accordance with rule 28 of its rules of procedure, appointed a Credentials Committee for its sixty-second session consisting of the following Member States: Angola, China, Chile, Namibia, the Russian Federation, Singapore, Switzerland, Suriname and the United States of America.
2. The Credentials Committee held its meeting on 18 December 2007.
3. Mr. Menon (Singapore) was unanimously elected Chairman.
4. The Committee had before it a memorandum by the Secretary-General dated 18 December 2007, concerning the credentials of representatives of Member States to the sixty-second regular session of the General Assembly.
5. As indicated in paragraph 1 of the memorandum of the Secretary-General, formal credentials in the form required by rule 27 of the rules of procedure of the General Assembly had been submitted by the following 130 States: Albania, Algeria, Andorra, Armenia, Australia, Austria, Bahamas, Bahrain, Bangladesh, Barbados, Belarus, Belgium, Benin, Bhutan, Bosnia and Herzegovina, Botswana, Brazil, Brunei Darussalam, Bulgaria, Burkina Faso, Burundi, Cambodia, Cameroon, Canada, Central African Republic, Chad, Chile, China, Costa Rica, Croatia, Cyprus, Czech Republic, Democratic People's Republic of Korea, Democratic Republic of the Congo, Denmark, Djibouti, Dominican Republic, Ecuador, Egypt, El Salvador, Eritrea, Finland, France, Gambia, Germany, Grenada, Guatemala, Guinea, Guyana, Hungary, Iceland, India, Indonesia, Iran (Islamic Republic of), Ireland, Israel, Italy, Jamaica, Japan, Jordan, Kazakhstan, Kiribati, Kuwait, Lesotho, Liberia, Libyan Arab Jamahiriya, Liechtenstein, Lithuania, Luxembourg, Madagascar, Malawi, Maldives, Malta, Marshall Islands, Mauritania, Mauritius, Mexico, Micronesia (Federated States of), Monaco, Mongolia, Morocco, Mozambique, Myanmar, Namibia, Nauru, Netherlands, New Zealand, Norway, Oman, Panama, Papua New Guinea, Paraguay, Peru, Poland, Portugal, Republic of Korea, Romania, Russian



Federation, Saint Kitts and Nevis, San Marino, Saudi Arabia, Senegal, Serbia, Seychelles, Singapore, Slovakia, Slovenia, Solomon Islands, Spain, Sri Lanka, Sudan, Suriname, Sweden, Switzerland, Syrian Arab Republic, Thailand, the former Yugoslav Republic of Macedonia, Togo, Trinidad and Tobago, Tunisia, Turkey, Ukraine, United Arab Emirates, the United Kingdom of Great Britain and Northern Ireland, United Republic of Tanzania, United States of America, Uruguay, Uzbekistan, Yemen, and Zimbabwe.

6. As indicated in paragraph 2 of the Secretary-General's memorandum, information concerning the appointment of their representatives to the sixty-second session of the General Assembly had been communicated to the Secretary-General, by means of a facsimile communication from the Head of State or Government or Minister for Foreign Affairs or by means of a letter or note verbale from the Permanent Mission concerned, by the following 58 Member States: Afghanistan, Angola, Antigua and Barbuda, Argentina, Azerbaijan, Bolivia, Colombia, Comoros, Cuba, Dominica, Equatorial Guinea, Estonia, Ethiopia, Fiji, Gabon, Georgia, Ghana, Greece, Guinea-Bissau, Haiti, Honduras, Iraq, Kenya, Kyrgyzstan, Lao People's Democratic Republic, Latvia, Lebanon, Malaysia, Montenegro, Nepal, Nicaragua, Niger, Nigeria, Pakistan, Palau, Philippines, Qatar, Republic of Moldova, Rwanda, Saint Lucia, Saint Vincent and the Grenadines, Samoa, Sao Tome and Principe, Sierra Leone, Somalia, South Africa, Swaziland, Tajikistan, Tonga, Turkmenistan, Tuvalu, Uganda, Vanuatu, Venezuela (Bolivarian Republic of), Viet Nam and Zambia.

7. As indicated in paragraph 3 of the Secretary-General's memorandum, the following 4 Member States have not made any communication to the Secretary-General: Cape Verde, Congo, Côte d'Ivoire and Timor-Leste.

8. The Chairman proposed the following draft resolution for adoption by the Committee:

*"The Credentials Committee,*

*"Having examined the credentials of the representatives to the sixty-second session of the General Assembly of the Member States referred to in paragraphs 5 and 6 of the report of the Credentials Committee,*

*"Accepts the credentials of the representatives of the Member States concerned."*

9. The draft resolution proposed by the Chairman was adopted without a vote.

10. The Chairman then proposed that the Committee should recommend to the General Assembly the adoption of a draft resolution entitled "Credentials of representatives to the sixty-second session of the General Assembly" (see para. 12). The proposal was adopted without a vote.

11. In the light of the foregoing, the present report is submitted to the General Assembly.

## **Recommendation of the Credentials Committee**

12. The Credentials Committee recommends to the General Assembly the adoption of the following draft resolution:

Credentials of representatives to the sixty-second session of the General Assembly

*The General Assembly,*

*Having considered* the report of the Credentials Committee and the recommendation contained therein,

*Approves* the report of the Credentials Committee.
