PROCEDURAL REPORT

Submitted by the Secretariat

1. The Third Review Conference of the High Contracting Parties to the Convention on Prohibitions or Restrictions on the Use of Certain Conventional Weapons Which May be Deemed to be Excessively Injurious or to Have Indiscriminate Effects (CCW) held at Geneva from 7 to 17 November 2006 decided, as contained in Decision 1 of its Final Document (CCW/CONF.III/11, Part II):

"To convene, as a matter of urgency, an intersessional meeting of governmental experts:

To consider further the application and implementation of existing international humanitarian law to specific munitions that may cause explosive remnants of war, with particular focus on cluster munitions, including the factors affecting their reliability and their technical and design characteristics, with a view to minimizing the humanitarian impact of the use of these munitions.

This meeting of governmental experts will, *inter alia*, consider the results of the meeting of experts on cluster munitions to be held by the ICRC. The meeting of governmental experts will report to the next meeting of the High Contracting Parties.

The Meetings of Military and Technical Experts of the GGE shall continue their technical work and provide further advice, as required."

- 2. The Third Review Conference decided, as contained in Decision 6 of its Final Document (CCW/CONF.III/11, Part II) on the organization of the 2007 CCW-related activities, and, *inter alia*, that the Group of Governmental Experts, including the continuation of the Meetings of Military and Technical Experts, shall be held from 19 to 22 June 2007.
- 3. The Third Review Conference decided, as contained in Decision 6 of its Final Document (CCW/CONF.III/11, Part II) to "appoint Ambassador Jānis Kārkliņš of Latvia as Chairperson of the GGE."

- 4. The 2007 Session of the Group of Governmental Experts was held at Geneva from 19 to 22 June 2007.
- 5. The following States Parties to the Convention participated in the work of the Group: Argentina, Australia, Austria, Belarus, Belgium, Bosnia and Herzegovina, Brazil, Bulgaria, Cambodia, Canada, Chile, China, Colombia, Croatia, Cuba, Cyprus, Czech Republic, Denmark, El Salvador, Estonia, Finland, France, Georgia, Germany, Greece, Guatemala, Holy See, Hungary, India, Ireland, Israel, Italy, Japan, Jordan, Latvia, Lithuania, Luxembourg, Malta, Mexico, Monaco, Morocco, Netherlands, New Zealand, Norway, Pakistan, Peru, Poland, Portugal, Republic of Korea, Romania, Russian Federation, Senegal, Serbia, Slovakia, Slovenia, South Africa, Spain, Sweden, Switzerland, The former Yugoslav Republic of Macedonia, Turkey, Ukraine, United Kingdom of Great Britain and Northern Ireland, United States of America, and Venezuela.
- 6. The following Signatory States to the Convention also participated in the work of the Group: Egypt.
- 7. The following States not parties to the Convention participated as observers: Azerbaijan, Burundi, Kuwait, Lebanon, Libyan Arab Jamahiriya, Malaysia, Qatar, Thailand, and United Arab Emirates.
- 8. The representatives of the United Nations Development Programme (UNDP), United Nations Institute for Disarmament Research (UNIDIR), and United Nations Mine Action Service (UNMAS) took part in the work of the Group.
- 9. The representatives of the International Committee of the Red Cross (ICRC) took part in the work of the Group. The representatives of the Geneva International Centre for Humanitarian Demining (GICHD) and the European Commission also participated in the work of the Group.
- 10. The representatives of the following non-governmental organisations also took part in the work of the Group: Cluster Munition Coalition, Handicap International, Human Rights Watch, International Campaign to Ban Landmines (ICBL), Landmine Action (UK), Mines Advisory Group (MAG), OXFAM, Pax Christi International, Swiss Campaign to Ban Landmines, and Women's International League for Peace and Freedom.
- 11. On 19 June 2007, the session was opened by the Chairperson, Ambassador Jānis Kārkliņš of Latvia.
- 12. The meetings of the Military and Technical Experts were chaired by Ms. Vera Bohle of GICHD. Mr. Peter Kolarov, Political Affairs Officer, Office for Disarmament Affairs, Geneva Branch, served as Secretary of the Group, and was assisted by Mr. Bantan Nugroho, Political Affairs Officer.
- 13. The Group held seven plenary meetings and considered the following issues: the military use of cluster munitions; the humanitarian impact of cluster munitions; the technical aspects of cluster munitions; the legal aspects of cluster munitions; definitions; and other relevant issues.

- 14. At its first plenary meeting, on 19 June 2007, the Group adopted its Agenda, as contained in Annex I, confirmed the Rules of Procedure as adopted and used by the Third Review Conference (CCW/CONF.III/11, Part III) and adopted its Programme of Work, as contained in Annex II.
- 15. During the course of the session, the Group of Governmental Experts considered documents CCW/GGE/2007/1 and CCW/GGE/2007/2, and CCW/GGE/2007/WP.1 to CCW/GGE/2007/WP.10, as well as CCW/GGE/2007/CRP.1, as listed in Annex IV. These documents are available in all official languages through the Official Document System of the United Nations at http://documents.un.org, and the official CCW website as part of the website of the United Nations Office at Geneva at http://www.unog.ch/disarmament/CCW.
- 16. The Group of Governmental Experts heard presentations by Germany on "Benchmarks for Alternative Munitions to Cluster Munitions. Sensor Fused Area Munitions (SEFAM)"; Russian Federation on "Technical Aspects of Cluster Munitions"; United Kingdom of Great Britain and Northern Ireland on "Legal Aspects of Cluster Munitions A Possible Framework for IHL Implementation Draft Proposals" and "Possible Definition of a Cluster Munition and a Submunition Draft Proposals"; United States of America on "The Ongoing Military Utility and Role of Cluster Munitions" and "Designing Self Destruct Fuzes"; UNDP on "Humanitarian Impact of Cluster Munitions"; ICRC on "Legal Issues related to the Use of Cluster Munitions"; GICHD on "Cluster Munitions: Overview of Existing and Proposed Definitions", "Technical Note on Mine Action. Lessons Learned from Cluster Munitions Clearance in Lebanon", and on the "Guide to Cluster Munitions"; Colin King of C. King Associates Ltd. on "The Evolution of Cluster Munitions" and "Cluster Munitions Technical Issues"; Human Rights Watch on "Humanitarian Issues Resulting from the Use of Cluster Munitions"; Mines Advisory Group on "Humanitarian Impact of Cluster Munitions".
- 17. The Group of Governmental Experts approved a recommendation to the 2007 Meeting of the High Contracting Parties to the Convention, as contained in Annex III.
- 18. As decided by the Third Review Conference, the Meeting of the High Contracting Parties to the Convention will be held from 7 to 13 November 2007.
- 19. At the final plenary meeting, on 22 June 2007, the Group of Governmental Experts adopted the procedural report of its 2007 session, contained in document CCW/GGE/2007/CRP.1, as orally amended, which is being issued as document CCW/GGE/2007/3.

Annex III

RECOMMENDATION

to the 2007 Meeting of the High Contracting Parties to the Convention (as approved at the final plenary meeting on 22 June 2007)

Recognizing the serious humanitarian concerns associated with the use of cluster munitions and having engaged in a substantive discussion on the application and implementation of existing humanitarian law to specific munitions that may cause explosive remnants of war, with particular focus on cluster munitions, including the factors affecting their reliability and their technical and design characteristics, the GGE, without prejudice to the outcome, recommends to the 2007 Meeting of the High Contracting Parties to the CCW to decide how best to address the humanitarian impact of cluster munitions as a matter of urgency, including the possibility of a new instrument. Striking the right balance between military and humanitarian considerations should be part of the decision.

The 2007 Meeting should take into account all documents put forward at the 2007 session of the GGE², as well as any other relevant documents and proposals."
