DRAFT PROGRAMME OF WORK 2008-2012

Note by the Secretariat

I. PROGRAMME ACTIVITIES

1. The ITC reviews its programme of work every two years for the following period of four years. At its sixty-eighth session in February 2006, the ITC adopted its programme of work for the period 2006-2010. The ITC Programme of Work for 2006-2010 (ECE/TRANS/166/Add.1) already addressed the priorities identified in the Work Plan on ECE Reform.

2. In order to take further into account the new priorities identified in the Work Plan on the ECE Reform, at its sixty-ninth session in February 2007, the ITC adopted a few new programme elements or amendments to existing ones, as contained in the Informal Document No. 1 of the fourth meeting of the ITC Bureau 2006-2007 held in February 2007.

3. The draft programme of work contained in this document has been prepared by the secretariat on the basis of the programme of work approved by the Inland Transport Committee at its sixty-eighth and sixty-ninth sessions and by its subsidiary bodies in the course of 2006 and 2007.

4. With a view to facilitating comparison of the description part of the attached draft programme with the text adopted by the respective subsidiary bodies of the Committee in 2006 and 2007, the secretariat has, where possible, indicated additional programme elements or elements replacing old text in bold characters while the texts proposed for deletion have been struck through.

II. GENERAL OBJECTIVES PURSUED BY THE ITC

In order to allow a better understanding of the scope of work of the Inland Transport 5. Committee, the general objectives pursued in carrying out the programme of work are outlined below. Through the pursuance of these objectives, the Committee intends (i) to promote the harmonization and improvement of technical and operational regulations, standards and recommendations in the various fields of inland transport in the UNECE region; (ii) to further the facilitation of international road, rail and inland waterway transport, particularly through the simplification and harmonization of administrative border crossing procedures and documentation; (iii) to promote the coordinated development of infrastructures for road, rail and inland waterway transport as well as for combined transport; (iv) to support the development of sustainable transport by means of promoting both the reduction of the negative impact of transport on the environment and the utilization of environmentally sound modes of transport; (v) to develop appropriate methodologies and definitions for the collection, compilation and harmonization of transport statistics for the purposes of comparability and consistency; (vi) to contribute to the elaboration, administration and revision of Agreements, Conventions and other international legally binding instruments in the various fields of inland transport; (vii) to monitor progressively the implementation of these international legal instruments in the various countries; (viii) to promote subregional cooperation with a view to such implementation and (ix) to advise and assist UNECE member countries, particularly those facing major economic changes through workshops, training and other appropriate means on transport matters of specific interest in particular in developing transport systems and infrastructures.

02.2.1 Road transport infrastructure

CONTINUING ACTIVITIES

I. <u>Implementation and amendment of the European Agreement on Main</u> International Traffic Arteries (AGR)

<u>Description</u>: In order to adapt the European road network to future requirements, the Working Party on Road Transport (SC.1) will take suitable action to implement the Agreement and amend as necessary its provisions taking into account the evolution of traffic flows, as well as the safety and security of the network.

Work to be undertaken:

(a) Consideration of the AGR Agreement in the light of new traffic flows.

Output expected by **2008-2009**: Adoption of amendments to Annex I to the AGR including new E-roads. Issuance of an updated map of the network **in 2008**.

(b) Consideration of the AGR Agreement or recommendations with a view to **Enhancing** AGR provisions and standards which have an impact on road safety, environmental protection and energy saving.

<u>Output expected by 2008-2009</u>: Preparation and possible adoption of new amendments to Annex II of the AGR or recommendations which relate to safety and security.

II. Trans-European North-South Motorway (TEM) Project

<u>Description</u>: In order to assist in the construction of the TEM network as part of an integrated international road infrastructure, the Working Party on Road Transport will continue its close cooperation with TEM.

Work to be undertaken:

(c) Review of ongoing and expected future progress in the TEM network and consideration of possibilities to contribute to its further development (e.g., combined transport, financing).

Output expected by 2008-2009: Development of the TEM Project and adhesion of new members to this Project

02.2.2 <u>Harmonization of requirements concerning international road transport</u> and facilitation of its operations

<u>Description</u>: In order to simplify and harmonize requirements concerning international road transport and the facilitation of its operation, the Working Party on Road Transport will elaborate and update, as necessary, appropriate international instruments **and/or recommendations** and study selected aspects of international transport of passengers and goods by road, particularly those related to the facilitation of road transport between eastern and western Europe and the simplification and harmonization of administrative procedures and documentation.

CONTINUING ACTIVITIES

Work to be undertaken:

(c)(d)Implementation of the European Agreement on the Work of Crews of Vehicles engaged in International Road Transport (AETR). Enhanced implementation of the AETR within the framework of the biennial evaluation.

<u>Output expected by 2008-2009</u>: Alignment of the AETR with new provisions adopted by the European Union Adoption of new provisions concerning the regulation of driving and rest periods for professional drivers. Organization of a Seminar on the introduction of the digital tachograph for non EU States. Priority: 1

Evaluation of the survey (to be conducted each two years) on the effective application of the AETR and number of problem areas identified and proposals to address them within the framework of the follow-up to the survey.

(d)(e) Consideration of questions concerning the Green Card International Motor Insurance System.

Priority: 1

PROGRAMME ACTIVITY 02.3: ROAD TRAFFIC SAFETY

Description: Mindful of the world-wide scope of its work, the Working Party on Road Traffic Safety (WP.1) will examine matters and adopt measures aimed at improving road traffic safety. To this end, it will consider, inter alia, the implementation of the Vienna Conventions on Road Traffic and on Road Signs and Signals and the European Agreements supplementing them and elaborate proposals for updating these legal instruments as well as the Consolidated Resolutions on Road Traffic and on Road Signs and Signals (R.E.1 and R.E.2). It will also seek to promote the global application of this work.

Work to be undertaken: The Working Party on Road Traffic Safety will pursue the following activities:

CONTINUING ACTIVITIES

Monitoring and encouraging the implementation of the Vienna Conventions (a) on Road Traffic and on Road Signs and Signals and the European Agreements supplementing them and the Protocol on Road Markings, and elaboration of amendment proposals to these legal instruments with a view to strengthening and harmonizing road safety standards.

Output expected by the end of 2008/2009:

- Consideration and/or adoption where appropriate of new amendment proposals to the above instruments concerning, inter alia, road signing; overtaking; definitions of mopeds, motorcycles, motorized tricycles and quadricycles, driving permits, use of telematics and vehicle safety systems, the the relationship between Annex 5 of the Convention on Road Traffic and UNECE vehicle regulations, and possibly security measures concerning road traffic recommended by the Multidisciplinary Group of Experts on Inland Transport Security.
- Publication of the Vienna Conventions and European Agreements supplementing them (incorporating the latest amendments).
- Publication of consolidated versions of the Vienna Conventions in the three other UN languages (Arabic, Chinese and Spanish)
- (b) Revision and updating of the Consolidated Resolutions on Road Traffic and on Road Signs and Signals (R.E.l and R.E.2).

Output expected by the end of 2008/2009:

Complete revision of R.E.1 and R.E.2 on the basis of a new structure and a new presentation - more attractive and modern with a view to their publication and dissemination in particular to the other Regional Economic Commissions;

Priority: 1

- Publication of the revised R.E.1 and R.E.2 including all recommendations already adopted, in particular those on periodic technical inspections, assistance to victims of road accidents, pedestrians, road works signing, speed control humps, contraflow cyclists since the revision work was launched;
- Consideration, development and incorporation into R.E.1 and R.E.2 of new recommendations concerning, in particular: seatbelts and child restraint devices, first aid to victims of road accidents, the safety of the most vulnerable road users, use of mobile phones while driving, safety in tunnels, skateboarders, roller skaters, etc., roadside checks, driving permits, driving under the influence of alcohol and drugs, road signing, motorcycle and moped safety, communication and road safety campaigns, daytime running lamps, driving at night, speed, aggressive driving, signs for fuelling stations selling compressed natural gas, etc
- Consideration, development and incorporation into R.E.2 of new recommendations concerning, in particular, variable message signs and possibly signing for cycle routes.
- (c) Exchange of information on national road safety programmes, in particular taking into account means of financing of road safety activities, and on road safety regulations and requirements in force in member States and circulation of such information in order to avail Governments of the practice and experience gained on these matters.

<u>Output expected by the end of 2008/2009</u>: Updating the set of tables reflecting current national road traffic safety requirements, national legal instruments and national methods of training and follow-up for categories A and B driving licences. **Possible** addition of new tables dealing, **for example**, with complementary safety equipment required on board vehicles. Issuance of annual information regarding road safety campaigns conducted by member countries.

(d) Assisting countries in transition and developing countries in the establishment of sound and up-to-date traffic safety practices and procedures.

<u>Output expected by the end of 2008/2009</u>: Respond to requests for technical assistance from other regional commissions or their member countries.

(e) Consideration of selected timely topics related to road safety in the form of an in-depth discussion based on papers prepared by experts and undertaking appropriate follow-up action with a view to finding concerted solutions to the most urgent problems in the field of traffic safety.

<u>Output expected by the end of 2008/2009</u>: Identification of at least one timely topic for in-depth discussion.

PROGRAMME ACTIVITY 02.4: DEVELOPMENT AND HARMONIZATION OF VEHICLE REGULATIONS

02.4.1. <u>Regulations for the construction of vehicles</u>

<u>Description</u>: The World Forum for Harmonization of Vehicle Regulations (WP.29) will develop regulations and recommendations for motor vehicles, their equipment and parts and harmonize and update the existing ones, including the relevant activities aimed at improving road transport safety, saving energy and taking into account the protection of the environment.

CONTINUING ACTIVITIES

Work to be undertaken:

- (a) In the framework of the "Agreement concerning the adoption of uniform technical prescriptions for wheeled vehicles, equipment and parts which can be fitted and/or be used on wheeled vehicles and the conditions for reciprocal recognition of approvals granted on the basis of these prescriptions" (1958 Agreement) and the "Agreement concerning the establishing of global technical regulations for wheeled vehicles, equipment and parts which can be fitted and/or be used on wheeled vehicles" (1998 Agreement), the World Forum will develop, harmonize and update Regulations in order to enhance performance of vehicles with respect to:
 - (i) general safety and anti-theft provisions.
 - (ii) pollution and energy.
 - (iii) brakes and running gear.
 - (iv) lighting and light-signalling.
 - (v) noise.
 - (vi) passive safety.

Output expected by the end of [2007] 2009:

- 1. Under the 1958 Agreement: Adoption of four new UNECE Regulations; Adoption of [seventy] **seventy-five** amendments to existing UNECE Regulations.
- 2. Under the 1998 Agreement: Implementation of an action plan for listing [ten] **five** Regulations in the Compendium of Candidates; The development of new global technical regulations (gtr); Establishment of [five] **four** harmonized or new global technical regulations (gtr) in the Global Registry.
- (b) Development of recommendations regarding the construction of vehicles (Consolidated Resolution R.E.3 and Special Resolution No. 1) with the aim of providing guidance with respect to requirements not covered by regulations. <u>Priority</u>: 1

<u>Output expected by the end of [2007]</u> **2009**: Adoption of two amendments to the existing Recommendations.

02.4.2. Rules on periodical technical inspections of vehicles

<u>Description</u>: The World Forum for Harmonization of Vehicle Regulations (WP.29) will develop rules for periodical technical inspections of wheeled vehicles with respect to their environmental and safety performance and for the reciprocal recognition of the results of such inspections.

CONTINUING ACTIVITIES

Work to be undertaken:

In the framework of the "Agreement concerning the adoption of uniform conditions for periodical technical inspections of wheeled vehicles and the reciprocal recognition of such inspections" (after its entry into force), the World Forum will develop one UNECE Rule for inspections of vehicles:

with regard to safety performance.

Priority: 1

<u>Output expected by the end of [2007]</u> **2009**: Adoption of draft Rule No. 2 (concerning inspections with respect to safety performance) to be annexed to the 1997 Agreement and adoption of an amendment to Rule No. 1 (concerning inspections with regard to environmental performance).

PROGRAMME ACTIVITY 02.5: RAIL TRANSPORT

02.5.1 Rail transport infrastructure

I. <u>Review of the situation concerning the implementation and possible amendments to the</u> European Agreement on Main International Railway Lines (AGC)

<u>Description</u>: Study of possibilities for the improvement of international railway lines and their reflection on AGC.

Work to be undertaken: The Working Party on Rail Transport will carry out the following activities:

CONTINUING ACTIVITIES

(a) Consideration of the AGC Agreement with a view to possibly: implementing and, whenever feasible, improving existing standards and operational parameters; also taking into account new east-west traffic flows; raising environmental, energy and safety standards; taking into account the UNECE Conventions on the Environment.

<u>Output expected</u>: Report on amendment of the AGC network; Report on the development of a European conventional and high-speed railway network. (2007)

Priority: 1

- II. Studies in Railway Infrastructure
- (a) <u>Description</u>: Study of the possibility of the improvement of international railway lines and their management.

Work to be undertaken: The Working Party will carry out the following activities:

Consideration of the influence of intermodal transport techniques, especially those concerning investment, as well as the harmonization of rolling stock and speed on railways to facilitate the integration of these techniques into the railway system and to create general interoperability.

<u>Output expected</u>: Report on investment in rail infrastructure and railway rolling stock in member countries. (2007)

(b) Periodic review of the list of marshalling yards of international importance with a view to cutting down their numbers.

Output expected: Updated report on the location of important marshallingyards within the European railway network. (2007)Priority: 2

(c) Consideration of questions concerning safety in railway tunnels.

<u>Output expected</u>: Review of the current situation and prospects for the development of new recommendations. (2008) <u>Priority</u>: 2

(d) Consideration of developments regarding new railway initiatives on Euro-Asian transport links (e.g. organization of demonstration trains).

<u>Output expected</u>: Report on the current and new initiatives. (2007) <u>Priority</u>: 2

(e) Periodically survey passenger and goods traffic on the various sections of lines of the AGC network in order to provide support for transport planning; the third survey is based on data for 2005.

Output expected: Report on total train traffic on the AGC network in 2000. (2007) Rail census in 2005. Priority: 2

(f) Consideration of other subjects as need arises.

Output expected: Report on each subject.

III. Special project: Trans-European Railway (TER)

<u>Description</u>: Within the framework of the UNECE, the TER countries have established an appropriate administrative and financial framework, with the aim of developing a rail network as part of an integrated European international rail system.

Work to be undertaken

(a) Report on specific project developments to promote international rail traffic. (Continuing)

<u>Output expected</u>: Annual progress report on activities carried out within the TER project. <u>Priority</u>: 1

(b) Report on possibilities for financing of TER in order to promote the upgrading and construction of internationally important rail lines. (Continuing)

PROGRAMME ACTIVITY 02.8: TRANSPORT, HEALTH AND ENVIRONMENT

Transport, Health and Environment Pan-European Programme (THE PEP)Priority: 1

<u>Description</u>: The Transport, Health and Environment Pan-European Programme (THE PEP) was established at the second High-level Meeting on Transport, Environment and Health (Geneva, 5 July 2002) to consolidate and focus the relevant UNECE and WHO Regional Office for Europe's activities on three key priority areas: (i) integration of environmental and health aspects into transport policy; (ii) demand-side management and modal shift; and (iii) urban transport. Special attention is paid to the needs of the newly independent States (NIS) and South-East European countries as well as to ecologically particularly sensitive areas of the region.

Activities in these key areas are coordinated and implemented by THE PEP Steering Committee, composed of UNECE and WHO/Europe member State representatives from the transport, environment and health sectors, in close cooperation with relevant international and non-governmental organizations. At its third session (11-12 April 2005) the Steering Committee agreed that in its programme of work for 2005-2007 the focus should continue to be on the activities that were currently implemented, i.e.:

- (a) Web-based clearing house on transport, health and environment;
- (b) Sustainable and healthy urban transport and land-use planning;
- (c) Transport-related health impacts, costs and benefits with particular focus on children;
- (d) Practical guidance on institutional arrangements and mechanisms for integrated policy and decision-making;
- (e) Promotion of safe walking and cycling in urban areas; and
- (f) Preparation of the third High-Level Meeting on Transport, Environment and Health [(2007)] (2008).

The third High-Level Meeting on Transport, Environment and Health is expected to provide further guidance on future activities to be carried out by THE PEP.

The Committee, the UNECE Committee on Environment Policy as well as WHO/Europe bodies will be informed of the activities undertaken under THE PEP.

(a) Review of relevant Conventions and Agreements on border crossing facilitation under the auspices of the Working Party in order to ensure their relevance and implementation as well as coherence with other international or sub-regional treaties and to keep them in line with modern transport and border control requirements.

Output expected in 2008:

Analysis of the application of the following UNECE Conventions on border crossing facilitation: TIR Convention 1975; **International Convention on the Harmonization of Frontier Controls of Goods 1982; International Convention to Facilitate the Crossing of Frontiers for Passengers and Baggage carried by Rail 1952**; ^{4/} Customs Conventions on the Temporary Importation of Private (1954) and Commercial (1956) Road Vehicles.

Consideration of the need for negotiating two model container pool agreements providing guidance to the transport industry and the Contracting Parties on the implementation of the provisions of the "Customs Container Pool Convention" covering international rail and international maritime transport.

Periodic review of Resolutions and Recommendations adopted by the Working Party with a view to confirming their usefulness and implementation as well as possible adopting modifications where deemed necessary.

Output expected in 2008:

Review of all Resolutions and Recommendations adopted by the Working Party with a view to deciding on which Resolutions and Recommendations to focus in the coming year. Priority: 1

Study of the possible extension of relevant UNECE Conventions on border crossing facilitation to other regions, particularly relating to legal and administrative aspects.

Output expected in 2008:

Preparation and organization of regional and/or national workshops, possibly in cooperation with UNESCAP, **ECA** and UNESCWA and other relevant UN and international organizations, on the implementation of relevant UNECE Conventions on border crossing facilitation, in particular in Asia, **North Africa** and the Middle East.

Study of Customs questions with a view to simplification of Customs formalities and documents in the field of transport, in particular taking account of the possibility of electronic data interchange solutions.

Output expected in 2008:

Analysis and revision of the provisions of both a strategic and technical nature of the TIR Convention, in particular the provisions relating to the guarantee system with a view to enhancing the functioning and efficiency for both the public and private partners in the TIR system;

Continuation of work on phase III of the TIR revision procedure, focusing on the revision of the TIR Carnet and on provisions for a modernized EDI-based Customs administration and control system.

Study of specific legal and other measures to combat fiscal fraud resulting from simplified Customs and other border crossing procedures, such as the TIR regime, including periodic review of the status of implementation of resolution No. 220 (prevention of the abuse of Customs transit systems by drug smugglers). Setting-up of mechanisms and administrative procedures for the regular exchange of information with other Governmental and non-governmental organizations to combat such fraud.

Output expected in 2008:

Preparation of adequate instruments and measures to improve international cooperation among Contracting Parties to the TIR Convention, 1975 and concerned national and international organizations to prevent fraud;

Review of Annex 10 of the TIR Convention on an international EDI control system for TIR Carnets;

Exchange of intelligence among Customs authorities of Contracting Parties to relevant UNECE Conventions on border crossing facilitation on abuses with a view to identifying measures to combat such occurrences.

PROGRAMME ACTIVITY 02.12: TRANSPORT STATISTICS AND INFORMATION

02.12.1 Methods of collection and definition of statistics on inland transport and road traffic accidents

Priority: 2

<u>Description</u>: Development of appropriate methodologies and terminology for the harmonization of statistics, aiming also at the determination of indicators of sustainable transport. This includes: methodologies for the collection and compilation of statistics on road, rail, inland waterway, pipeline and combined transport as well as on road traffic accidents, in cooperation and coordination with other UNECE bodies, related international organizations, in order to promote the availability of comprehensive, timely and reliable statistics for sustainable transport planning and analysis.

Work to be undertaken: The Working Party on Transport Statistics will pursue the following activities:

CONTINUING ACTIVITIES

(a) Target solutions to improve the collection of statistics in problematic areas, as indicators of sustainable transport, including, but not limited to the following items:

Statistics on road traffic (vehicle-km) (output of feasibility survey expected in 2008); Statistics on the transportation by buses and coaches (output expected in 2008); Statistics on the environmental impact of transport; Statistics on the transport of dangerous goods; Statistics on transport through pipelines.

<u>Output expected</u>: A concrete decision for each problematic area, e.g., the addition of supplementary chapters to the Common Questionnaire for Transport Statistics (environment; gas transport via pipelines) (2008); an assessment of the applicability of the EU Regulations for the collection of dangerous goods data for non-EU member states (2008); and the organization of informal working groups on statistics on transport through pipelines and on transport by buses and coaches, as deemed necessary (2007), and assessment of metadata on statistics on the volume of these transports (2008).

(b) Statistics related to transports and the environment.

<u>Output</u> expected: Continued progress toward the integration of environment-related variables into the Common Questionnaire for Transport Statistics, as well as the two annual transport publications.

Priority: 1

(c) Coordination among member Governments, other UNECE bodies and related international organizations and non-governmental organizations to harmonize terminology used in the statistics of road, rail, inland waterway, pipeline, combined transport and road traffic accidents, including, but not exclusively, in the context of the work being undertaken by the Intersecretariat Working Group on Transport Statistics (UNECE-International Transport Forum-EC/Eurostat) (Meetings 2-3 times per year).

Priority: 2

<u>Output expected</u>: Improving electronic transmission of the Common Questionnaire for Transport Statistics (2007); development of supplementary questionnaires as decided by the Intersecretariat Working Group on Transport Statistics (IWG) and WP.6; preparation of meetings of IWG; publication of the update of the third edition of the Glossary for Transport Statistics (2008).

(d) Development of common methodologies to facilitate and improve the collection of information on road and rail traffic flows and infrastructure parameters through surveys and censuses such as automatic counting procedures, including, but not limited to, in the context of The Combined Census of Motor Traffic and Inventory of Standards and Parameters on Main International Traffic Arteries in Europe (E Road Census and Inventory), (compiled and published by the UNECE every five years, next publication in 2008).

Development of common methodologies for E-Rail Censuses to obtain data on traffic flows and infrastructure parameters on the AGC network. Results of the first E-rail census in 2005 are expected to be published in 2008. <u>Priority</u>: 1

(e) Monitoring of developments in the field of transport database and information systems, including geographic information systems (GIS), in order to facilitate the updating, analysis and geographic application of transport data, within UNECE and in cooperation with the International Transport Forum and EC/Eurostat, to harmonize transport data internationally and avoid duplication of efforts with other organizations.

<u>Output expected</u>: The development of a transport database system at UNECE based on the data collected through the Common Questionnaire for Transport Statistics. Consideration of various alternatives and progress made (Acces/Excel, Internet/WWW, etc.); observation of trial-run at International Transport Forum and Eurostat (2007).

(f) Development of projects to assist countries in transition in the collection, organization and automation of transport statistics, including the convening of workshops and training seminars, drawing on the expertise of member Governments and related organizations. Output expected: Information from Member States and international organizations on relevant activities.

02.12.2 Publication of statistical information in the field of transport <u>Priority</u>: 1

<u>Description</u>: Collection and compilation of statistics on inland transport, traffic accidents and traffic flows published by the UNECE.

<u>Work to be undertaken</u>: The Working Party on Transport Statistics will pursue the following activities:

- (g) Build and maintain a database for the annual collection of statistics on inland transport, including combined transport and road traffic accidents from UNECE member Governments to be published in the following publications:

 - (ii) Statistics of Road Traffic Accidents in Europe and North America (RAS)
 - (iii) Handbook of Transport Statistics

<u>Output expected</u>: Publication of ABTS, RAS and Handbook of Transport Statistics; Circulation of Questionnaires and receipt of data from member Governments for ABTS and RAS in electronic format. The handbook may be also published in booklet format.

(i) Use of PC-Axis for disseminating data collected via the regular questionnaires.

Output expected: Availability of main data online (2008)

(j) Provide methodological support for the ongoing analysis and evaluation of statistical publications to continue to improve the quality and presentation of the publications, and to incorporate harmonized terminology through the work of the Intersecretariat Working Group on Transport Statistics. Develop strategies for improvement of usefulness and presentation of publications.

<u>Output expected</u>: Concrete feedback from Governments and other users on usefulness and presentation of publications and development of strategies for improvement of both.
