SECOND REPORT BY THE SECRETARY-GENERAL ON THE IMPLEMENTATION
OF SECURITY COUNCIL RESOLUTIONS S/4387 OF 14 JULY 1960 AND
S/4405 OF 22 JULY 1960

Addendum No. 10

In my addendum No. 6 of 31 July 1960 to my first report to the Security Council on the implementation of resolution S/4387 of 14 July 1960, I summarized the strength of the United Nations Force on duty in the Republic of the Congo as of 31 July and indicated the key points at which units of the Force were then deployed.

In this addendum to my second report to the Security Council dated 6 August 1960, on the implementation of Security Council resolutions S/4387 of 14 July 1960 and S/4405 of 22 July 1960, I summarize the strength of the United Nations Force reported to be on duty in the Republic of the Congo as of 19 August 1960 and indicate the key points at which units of the Force are deployed. For the convenience of the members of the Council, a map is attached showing the points of deployment as well as the nationality of the unit deployed at each point. It should be noted that units of newly arriving troops are being deployed to additional points as they arrive and that some units of the Force already in the Congo on 19 August 1960 are being and will continue to be re-deployed as the situation warrants.

Contingents of the United Nations Force in the Republic of the Congo

Ethiopian Battalions: Headquarters at Stanleyville and Kamina, with units deployed at Lisala, Bumba, Aketi, Buta, Ango, Banbizi, Poko, Niangara, Dungu, Paulis, Mambasa, Bunia, Yahuma, Basoko, Isangi, Baulo, Ponthierville, Ramazani, Opala, Aru.

Ghanaian Battalions: Headquarters at Leopoldville, with units deployed in the City.

Guinean Battalion: Headquarters at Banningville, with units deployed at Kwamouth, Mushie, Mabenga, Nioki, Kutu, Inongo, Oshwe.

Irish Battalions: Headquarters at Goma and Kamina, with units deployed at Bukavu, Kindu, Kasongo.

Liberian Company: Headquarters at Libenge, with units deployed at Kungu, Bosobolo, Banzyville, Gemena.

Malian Battalion: Headquarters at Kongolo-Albertville, with units deployed at Kabalo, Nyunzu, Beaudouinville, Manono.

Moroccan Battalions: Headquarters at Leopoldville-Thysville-Matadi and Jadotville, with units deployed at Tshela, Kitona, Lukula, Boma, Lufu, Songololo, Lukala, Moerbeke, Elisabethville, Kolwezi, Kizia, Popokabaka, Coquilhatville, Boende, Kikwit, Leverville.

Sudanese Battalion: Headquarters at Leopoldville, with units deployed in the City.

Swedish Battalion: Headquarters at Elisabethville, with units deployed at Jadotville, Kolwezi.

Tunisian Battalions: Headquarters at Luluabourg, with units deployed at Port-Franqui, Mweka, Luebo, Tshikapa, Lusambo, Bakwanga, Kabinda, Gandajika, Luputa, Kumba.

Troops of the following countries are now on duty in the Republic of the Congo in the strengths indicated:

In addition to the above, a battalion of 520 men from the United Arab Republic is scheduled to arrive in Libenge within a day or two and a battalion from Indonesia has been offered to and accepted by the United Nations Force and will arrive in the Republic of the Congo when transportation can be arranged. Also, an additional company of Tunisian troops is due to arrive in Luluabourg within a day or two.

In addition to the troops composing the main body of the United Nations Force in the Congo, various support units from other countries have been or are being provided; among these are a supply unit and an air despatch team from India, an ordnance unit from Pakistan, a bilingual signal unit from Canada, a workshop control and supervisory team from Denmark and Norway, an engineer workshop unit and two movement control teams from Sweden, one movement control team from Liberia, and two hygiene teams from the Netherlands. Requests have been made for other similar type support units from several countries, but replies have not yet been received.

For the operation of the United Nations airlift in the Republic of the Congo, pilots, air and ground crews, mechanics, and maintenance personnel have been provided by Argentina, Brazil, Ethiopia, India, Norway, Sweden and Yugoslavia. Staff officers have been provided by most of the above countries and by Burma and Ceylon, in addition to those on temporary assignment from UNTSO and UNEF.
