## Extensions of country programmes in the Asia and the Pacific region

# **Note by the Executive Director**

### *Summary*

The present note contains information on the one-year extension of the country programme for Afghanistan and the two-year extension of the country programme for Pakistan.

In accordance with established procedures, the Executive Director approves the first one-year extension of a country programme, while requests for extensions for a second year or two-year extensions are submitted to the Executive Board for approval.

The Executive Board may wish to take note of the one-year country programme extension for Afghanistan as indicated in table 1, and approve the two-year extension of the country programme for Pakistan, as indicated in table 2.

Afghanistan	2006-2008	2009	The formulation of the Afghanistan national development strategy will begin in March 2008. As a result, the United Nations country team has recommended that the development of the United Nations Development Assistance Framework be undertaken in 2008, after the finalization of the national development strategy.	The development of the Afghanistan national development strategy is a government-led process. It is supported by the international community, under the auspices of the Joint Coordination and Monitoring Board, which is co-chaired by the Government and the United Nations Assistance Mission in Afghanistan.
