#### Monday, 26 May 2008

# Item 3 Activities of ECE bodies and international organizations of interest to the Working Party

#### (a) Inland Transport Committee and its subsidiary bodies

The Inland Transport Committee (ITC), at its seventieth session (19-21 February 2008), took note of the report of the Working Party on its one-hundred-and-first session (ECE/TRANS/200).

#### (b) International organizations

Representatives of international organizations at the session are invited to present briefly information regarding their activities to the Working Party.

#### Item 4 Implementation of the AETR

#### (a) Consideration of proposed amendments to the AETR

Having in mind discussions during the one-hundred-and-first session of the Working Party regarding harmonisation of provisions between the AETR and the EU Regulation 561/2006, the Working Party is expected, at this special session which is supported by the ITC, to reach a mutually acceptable compromise on points under discussion (article 8, paragraph 6 and form in appendix 3 of ECE/TRANS/SC.1/2007/3/Rev.1). If new proposals are submitted, they will be presented in a new document ECE/TRANS/SC.1/2008/1.

The Working Party is also expected to review the content of document ECE/TRANS/SC.1/2007/3/Rev.1 and to take a decision concerning the possible opening of the AETR to non-ECE countries (ECE/TRANS/SC.1/AC.6/2006/2) in order to enable the final adoption of amendments at its One-hundred-and-third session in October 2008.

#### (b) Questionnaire on checking of driving and rest times

The Working Party will be informed on the developments regarding the survey on checking of driving and rest times (ECE/TRANS/SC.1/2007/1).

#### (c) Implementation of the digital tachograph

The Working Party will be informed on latest developments concerning the implementation of the digital tachograph and the publication of the Appendix 1B (ECE/TRANS/SC.1/2006/2/Add.1).

#### Item 5 Opening of the signing ceremony – Additional Protocol to the CMR

#### Tuesday, 27 May 2008

Accredited representatives of the Contracting Parties to the CMR will be invited on **27 May 2008** to sign the Additional Protocol to the Convention on the Contract for the

International Carriage of Goods by Road (CMR) during this session of the Working Party. This Additional Protocol concerns the Electronic Consignment Note as adopted by the Inland Transport Committee on 20 February 2008. Following this signing ceremony, the Additional Protocol will be open for signature at the United Nations Office in Geneva during the period 27-30 May 2008. After this, other United Nations Member Countries are welcome to accede to this Additional Protocol, at the United Nations Headquarters in New York until 30 June 2009.
