**Sixty-third session****Report of the Trade and Development Board on its  
twenty-fourth special session\***

**Geneva, 17-20 March 2008**

**Opening of the session**

1. The session was opened by Mr. Petko Draganov (Bulgaria), President of the Trade and Development Board.
2. Opening statements were made by Dr. Supachai Panitchpakdi, the Secretary-General of UNCTAD; the representative of Brazil, on behalf of the G77 and China; the representative of Slovenia, on behalf of the European Union; the representative of Chad, on behalf of the African Group; the representative of the Philippines, on behalf of the Asian Group; the representative of Cuba, on behalf of the Group of Latin America and Caribbean Countries (GRULAC); the representative of Bangladesh, on behalf of the Least Developed Countries (LDCs) Group; the representative of the Russian Federation, on behalf of Group D; the representative of the United States, on behalf of Japan, the United States, Switzerland, Canada, Australia, Norway and New Zealand (JUSSCANNZ), as well as Israel and Turkey; the representative of Thailand; the representative of China; the representative of Mexico; and the representative of Belarus.<sup>1</sup>

**I. Adoption of the agenda and organization of work**

3. The Board adopted the provisional agenda contained in document TD/B (S-XXIV)/1 (see annex I).

### **Selection by drawing of lot of the country that will head the seating pattern at the twelfth session of the Conference**

4. In accordance with established practice, Sudan was drawn by lot to be first in the alphabetical order to be used for seating arrangements at UNCTAD XII.

## **III. Substantive preparations for the twelfth session of the Conference**

5. The representative of Ghana gave a presentation on the preparations for UNCTAD XII. He updated the Board on the host country's preparations concerning the conference facilities, hotel accommodations, transportation, visas, health services, security and publicity.

6. The President of the Trade and Development Board presented to the session the report of the Preparatory Committee for the twelfth session of the Conference, contained in document TD/B(S-XXIV)/L.2. He also presented reports on the two hearings with civil society, contained in documents TD(XII)/PC/2 and TD(XII)/PC/3. The Board took note of all three reports.

7. The President of the Trade and Development Board said that he had no negotiating text from the Preparatory Committee for the twelfth session of the Conference to present to the session because negotiations were still ongoing. He said that the Preparatory Committee was in crisis mode because of the lack of progress in the text, and called on member States to continue to make every effort to see that the negotiations progressed at a faster pace.

### **A. Report of the Commission on Trade in Goods and Services, and Commodities, twelfth session**

11. The Board approved Kazakhstan's and Montenegro's membership of the Trade and Development Board.

12. The Board approved the addition of Estonia, Montenegro and Kazakhstan to list D of the lists of States referred to in General Assembly resolution 1995 (XIX). In the case of Kazakhstan, Group D requested that the application be approved with the understanding that its decision would be without prejudice to the composition of the five United Nations regional groups for the purpose of the distribution of posts within the United Nations General Assembly and its bodies in New York. The Board accepted the changes as requested by Group D.

**B. Designation of intergovernmental bodies for the purposes of rule 76 of the rules of procedure of the Board**

13. There were no additional intergovernmental bodies for consideration by the Board.

**C. Designation of and classification of non-governmental organizations for the purposes of rule 77 of the rules of procedure of the Board**

14. There were no additional non-governmental organizations for consideration by the Board.

**D. Provisional calendar of meetings for the remainder of 2008 and draft schedule of meetings for 2009**

15. The Chief of the Conference Services and Logistics Section of the UNCTAD secretariat presented the provisional calendar of meetings for the remainder of 2008 and draft schedule of meetings for 2009, as contained in document TD/B (S-XXIV)/CRP.1, which was approved by the Trade and Development Board.
